AMENDMENT NO. 1. Page 1, line 8, restore the title to read
AN ACT RELATING TO LOW-LEVEL RADIOACTIVE WASTE;
AMENDING 63 O.S. 1991, SECTIONS 1-2102 AND 1-2104,
WHICH RELATE TO THE CENTRAL INTERSTATE LOW-LEVEL
RADIOACTIVE WASTE COMPACT COMMISSION; STATING
ACTIVITIES OF COMMISSION ARE PUBLIC BUSINESS;
DEFINING TERMS; MODIFYING DEFINITIONS; AUTHORIZING
HOST STATE TO PROPOSE CERTAIN FAIR AND REASONABLE
FEES WITH CERTAIN NOTICE TO COVER CERTAIN COSTS;
STATING CERTAIN USES FOR FEES; STATING ALL PARTY
STATES SHALL BE LIABLE FOR COSTS; REQUIRING
EXHAUSTION OF CERTAIN FUNDS BEFORE FUNDS MAY BE
RECOVERED FROM PARTY STATES; PROVIDING PROCEDURES
IN EVENT OF BANKRUPTCY BY FACILITY OPERATOR;
STATING LIABILITIES OF STATE SHALL BE PROPORTIONED
TO VOLUME OF GENERATED WASTE; MODIFYING NAME OF
COMMISSION; MODIFYING MEMBERSHIP OF COMMISSION;

PROVIDING FOR ALL COMMISSION MEETINGS TO BE OPEN TO THE PUBLIC; REQUIRING ADVANCE NOTICE OF MEETING; STATING SUCH MEETING SHALL BE SUBJECT TO CERTAIN OPEN MEETINGS LAWS; REQUIRING COMMISSION TO ADOPT CERTAIN BYLAWS; REQUIRING FILES, RECORDS AND DATA TO BE OPEN TO PUBLIC INSPECTION AND SUBJECT TO CERTAIN OPEN RECORDS LAWS; PROVIDING FOR ALL DECISIONS RELATING TO PUBLIC MEETINGS AND PUBLIC RECORDS TO BE REVIEWABLE ONLY IN UNITED STATES DISTRICT COURT; REQUIRING STATE REVOKED BY COMMISSION TO CONTRIBUTE CERTAIN FEE TOWARD ANNUAL BUDGET; AUTHORIZING THE COMMISSIONER OF HEALTH TO DESIGNATE A REPRESENTATIVE TO COMMISSION; REMOVING REQUIREMENT FOR CERTAIN ALTERNATE TO COMMISSION; PROVIDING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY."

AMENDMENT NO. 2. Page 9, Section 1, line 10, after the period, strike the language "An independent certified public accountant" and insert

"A licensed public accountant or a certified public accountant holding a permit to practice in this state"
