SECTION 5-110, AS LAST AMENDED BY SECTION 7,
CHAPTER 293, O.S.L. 1990 (70 O.S. SUPP. 1990,
SECTION 5-110), WHICH RELATES TO WORKSHOPS FOR NEW
SCHOOL BOARD MEMBERS; DELETING CERTAIN NOTIFICATION
REQUIREMENTS CONCERNING FEES; MODIFYING
QUALIFICATIONS AND REQUIREMENTS FOR CERTAIN
REIMBURSEMENT; REPEALING SECTION 2, CHAPTER 257,
O.S.L. 1990 (70 O.S. SUPP. 1990, SECTION 5-110),
WHICH IS A DUPLICATE SECTION WHICH RELATES TO
WORKSHOPS FOR NEW SCHOOL BOARD MEMBERS; AND
DECLARING AN EMERGENCY.

AMENDMENT NO. 1. Page 1, Section 1, lines 26 and 27, after the
word "Education" on line 26, and before the word "for" on
line 27, strike the words

"in cooperation with the Oklahoma State School
Boards Association"

AMENDMENT NO. 2. Page 1, Section 1, lines 30 and 31, after the
word "Education" on line 30, and before the word "shall"
on line 31, strike the words

"in cooperation with the Oklahoma State School
Boards Association"

AMENDMENT NO. 3. Page 2, Section 1, line 5, after the word "following" and before the word "his" delete the words

"or preceding"

AMENDMENT NO. 4. Page 2, Section 1, lines 7 and 8, after the word "conducted" on line 7, and before the word "on" on line 8, strike the words

"by the Oklahoma State School Boards Association as instruction"

AMENDMENT NO. 5. Page 2, Section 1, lines 28 and 29, after the word "Education" on line 28, and before the word "authorized" on line 29, strike the words

"and the Oklahoma State School Boards Association are"

and insert the word "is"

AMENDMENT NO. 6. Page 3, Section 1, line 11, after the period insert a new sentence to read

"Members not seated at the time they attend such workshop shall not be paid the reimbursement until they have been seated."

AMENDMENT NO. 7. Page 3, line 11 1/2, insert a new subsection E to read

"E. The State Board of Education is authorized to obtain the assistance of any organization representing public school boards in this state for the purposes of carrying out the requirements of this act."

AMENDMENT NO. 8. Page 1, line 9 in the title, after the semicolon and before the word "DELETING" insert the words

"STRIKING REFERENCES TO CERTAIN ORGANIZATIONS;
AUTHORIZING CERTAIN ASSISTANCE;"
