AN ACT RELATING TO THE OKLAHOMA COMMISSION ON  
CHILDREN AND YOUTH; MAKING AN APPROPRIATION  
THERE TO; STATING THE PURPOSE; PROVIDING FOR DUTIES  
AND COMPENSATION OF EMPLOYEES; LIMITING THE SALARY  
OF THE DIRECTOR; LIMITING THE NUMBER OF  
FULL-TIME-EQUIVALENT EMPLOYEES; LIMITING CERTAIN  
EXPENDITURES; REQUIRING CERTAIN BUDGET WORK PROGRAM  
CATEGORIES; PROVIDING LAPSE DATE; PROVIDING AN  
OPERATIVE DATE; AND DECLARING AN EMERGENCY.

AMENDMENT NO. 1. Strike the title, enacting clause and entire bill  
and insert

"AN ACT RELATING TO THE OKLAHOMA COMMISSION ON CHILDREN AND  
YOUTH; MAKING AN APPROPRIATION THERE TO; STATING THE  
PURPOSE; PROVIDING FOR DUTIES AND COMPENSATION OF  
EMPLOYEES; LIMITING THE SALARY OF THE DIRECTOR; LIMITING  
THE NUMBER OF FULL-TIME-EQUIVALENT EMPLOYEES; LIMITING  
CERTAIN EXPENDITURES; REQUIRING CERTAIN BUDGET WORK PROGRAM  
CATEGORIES; PROVIDING LAPSE DATE; PROVIDING AN OPERATIVE  
DATE; AND DECLARING AN EMERGENCY.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Oklahoma  
Commission on Children and Youth from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the following amount or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission on Children and Youth by law:

Contractual Services of the Oklahoma Area-Wide Service Information System (OASIS)	\$78,750.00
Contractual Services of the University of Oklahoma Personnel Training Program	225,000.00
Contractual Services of the Oklahoma Court Appointed Special Advocates (CASA) Association	75,000.00
Personal Services	685,790.00
Other Operating Expenses	<u>110,500.00</u>
TOTAL OPERATIONS	\$1,175,040.00

SECTION 2. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Commission on Children and Youth by law shall be set by the Director. The salary of the Director shall not exceed Forty-three Thousand Nine Hundred Dollars (\$43,900.00) per annum, payable monthly for the fiscal year ending June 30, 1992. The Oklahoma Commission on Children and Youth for the fiscal year ending June 30, 1992, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 3. Pursuant to the provisions of Section 41.7 of Title 62 of the Oklahoma Statutes, the Oklahoma Commission on Children and Youth shall file its budget work program with the Director of State Finance and the Legislative Service Bureau for the fiscal year ending June 30, 1992, to include the following budget entities and activities:

- General Administration
- Juvenile Justice Operations
- Juvenile Justice Grants
- Interagency Coordinating Council
  - for P.L. 99-457
- CASA Program
- O.U. Juvenile Personnel Training Program
- OASIS Program

SECTION 4. The appropriation made by this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1992. Any unexpended funds remaining after November 15, 1992, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 5. This act shall become operative July 1, 1991.

SECTION 6. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval."
