AN ACT RELATING TO PUBLIC FINANCE AND CITIES AND
TOWNS; AMENDING 62 O.S. 1981, SECTION 41.21, AS
LAST AMENDED BY SECTION 15, CHAPTER 265, O.S.L.
1990 (62 O.S. SUPP. 1990, SECTION 41.21), WHICH
RELATES TO PAYMENT OF CERTAIN CLAIMS OR PAYROLLS;
AUTHORIZING THE STATE SYSTEM OF HIGHER EDUCATION TO
ESTABLISH A SYSTEM FOR CLAIM SETTLEMENT; PROVIDING
PROCEDURES AND LIMITATIONS; AMENDING 11 O.S. 1981,
SECTION 52-105, AS AMENDED BY SECTION 18, CHAPTER
258, O.S.L. 1986 (11 O.S. SUPP. 1990, SECTION 52-
105), WHICH RELATES TO TRAINING OF CERTAIN
MUNICIPAL EMPLOYEES; MODIFYING TRAINING REQUIRED OF
CERTAIN MUNICIPAL EMPLOYEES; AND DECLARING AN
EMERGENCY.

AMENDMENT NO. 1. Page 1, lines 7 1/2 through 14, strike the title
to read

"[PUBLIC FINANCE AND CITIES AND TOWNS - PAYMENT
OF CERTAIN CLAIMS OR PAYROLLS - AMENDING 62
O.S., SECTION 41.21 AND 11 O.S., SECTION
52-105 -

EMERGENCY]"

AMENDMENT NO. 2. Page 1, Section 1, line 21, after the letter "A." and before the word "for" strike the word "Procedures" and insert the words

"Except as otherwise provided by subsections B and C of this section, procedures"

AMENDMENT NO. 3. Page 3, Section 1, lines 6, 7 and 7 1/2, after the word "Examination;" on line 6, strike the word "and"

and on lines 7 and 7 1/2, before the period insert "; and

16. Any contract for service for which the office of public affairs has approved as qualifying for a fixed and uniform rate pursuant to Section 85.7 of Title 74 of the Oklahoma Statutes"

AMENDMENT NO. 4. Page 3, Section 1, lines 16 through 25, delete subsection C and insert a new subsection C to read

"C. Provisions of subsection A of this section notwithstanding, the Oklahoma State Regents for Higher Education and the Director of State Finance shall jointly establish a system for the settlement of claims, excepting payroll, by entities of The Oklahoma State System of Higher Education. The settlement system shall include policy, procedures, and performance criteria for participation. The State Regents are authorized to approve or disapprove the participation of any institution or other entity of the State System in the claims settlement system."
