AN ACT RELATING TO PUBLIC HEALTH AND SAFETY; AMENDING
63 O.S. 1981, SECTION 1-1902, AS LAST AMENDED BY
SECTION 17, CHAPTER 337, O.S.L. 1990, 1-1903, AS
LAST AMENDED BY SECTION 23, CHAPTER 98, O.S.L.
1987, 1-1904, AS AMENDED BY SECTION 25, CHAPTER 98,
O.S.L. 1987, 1-1905, 1-1906, AS AMENDED BY SECTION
26, CHAPTER 98, O.S.L. 1987, 1-1911, AS LAST
AMENDED BY SECTION 24, CHAPTER 98, O.S.L. 1987, 1-
1912, 1-1915, 1-1918, AS AMENDED BY SECTION 1,
CHAPTER 171, O.S.L. 1982, 1-1931 AND SECTION 30 AND
31, CHAPTER 227, O.S.L. 1989 (63 O.S. SUPP. 1990,
SECTION 1-1902, 1-1903, 1-1904, 1-1906, 1-1911, 1-
1916.1, 1-1916.2 AND 1-1918), WHICH RELATE TO THE
NURSING HOME CARE ACT; DELETING CERTAIN DEFINITION;
CLARIFYING LANGUAGE; MODIFYING INFORMATION AND
FACTORS REQUIRED FOR LICENSE; PROVIDING FOR INITIAL
LICENSES; ADDING TO AND MODIFYING PENALTIES;
MODIFYING APPLICATION AND LICENSING PROCEDURES;
MODIFYING REASONS FOR DENYING A LICENSE; MODIFYING
INSPECTION PROCEDURES AND CERTAIN REPORTING
REQUIREMENTS; MODIFYING BASIS FOR PENALTY
ASSESSMENT; ADDING TO, MODIFYING AND CLARIFYING
CERTAIN RIGHTS AND RESPONSIBILITIES; PROVIDING FOR

APPOINTMENT OF TEMPORARY MANAGER, RECEIVER OR
MONITOR AND MODIFICATION OF THEIR DUTIES; ADDING TO
AND MODIFYING REASONS FOR CERTAIN APPOINTMENTS;
ADDING TO POWERS AND DUTIES OF DEPARTMENT OF
HEALTH; MODIFYING POWERS OF CERTAIN COURTS;
PROVIDING FOR DEPOSIT OF CERTAIN FUNDS; REPEALING
63 O.S. 1981, SECTION 1-1907 AND 1-1913, WHICH
RELATE TO CERTAIN STATEMENT OF OWNERSHIP AND
CERTAIN MONTHLY LISTS; AND DECLARING AN EMERGENCY.

AMENDMENT NO. 1. Page 4, Section 1, lines 16, 17 and 19, restore
the stricken words

"Section 1-1902 et seq. of this title," on line
16

"Section 1-819 et seq. of this title," on line 17
and "Section 1-818.1 et seq. of this title," on
line 19

AMENDMENT NO. 2. Page 7, Section 3, line 11, after the word
"receivership," and before the word "administrative"
delete the word "significant"

AMENDMENT NO. 3. Page 13, Section 6, lines 24 through 32, restore
the stricken language

"E. The Department shall make at least one annual report on
each facility in the state. All conditions and practices not in
compliance with applicable standards within the year for which the
report is made shall be specifically stated. If a violation is
corrected or is subject to an approved plan of correction, such
action shall be specified in the annual report. Upon receiving a
written request for a copy of the annual report, the Department
shall send a copy of the report to any person making the written
request. The Department may charge a reasonable fee for copying
costs."

AMENDMENT NO. 4. Page 16, Section 9, line 7, after the word "Act"
and before the period insert the words

" , Section 309 et seq. of Title 75 of the
Oklahoma Statutes "

AMENDMENT NO. 5. Page 1, in the title, lines 17 1/2 through 18 1/2, after the semicolon on line 17 1/2 and before the word "PROVIDING" on line 18 1/2, delete the words

"ADDING TO, MODIFYING AND CLARIFYING CERTAIN RIGHTS AND RESPONSIBILITIES;"
