ADOPTION OF COUNTY PRIMARY ROAD SYSTEM; PROVIDING
FOR THE CONSTRUCTION AND MAINTENANCE OF THE ROADS
IN THE COUNTY PRIMARY ROAD SYSTEM; REQUIRING
CERTAIN MARKING FOR SUCH ROADS; CLARIFYING
