AN ACT RELATING TO THE COURT OF CRIMINAL APPEALS;
MAKING AN APPROPRIATION AND REAPPROPRIATION
THERE TO; STATING THE PURPOSE; PROVIDING FOR THE
DUTIES AND COMPENSATION OF EMPLOYEES; LIMITING THE
SALARY OF JUDGES; PROVIDING BUDGETARY LIMITATIONS;
PROVIDING LAPSE DATE; PROVIDING AN EFFECTIVE DATE;
AND DECLARING AN EMERGENCY.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Court of
Criminal Appeals from any monies not otherwise appropriated from the
General Revenue Fund of the State Treasury for the fiscal year
ending June 30, 1992, the following amount or so much thereof as may
be necessary to perform the duties imposed upon the Court of
Criminal Appeals by law:

SECTION 2. REAPPROPRIATION The amount of Forty-four
Thousand One Hundred Twenty-eight Dollars (\$44,128.00) originally
appropriated by Section 19, Chapter 264, O.S.L. 1990, to the Court
of Criminal Appeals, from any monies not otherwise appropriated from
the General Revenue Fund of the State Treasury, for the fiscal year

ending June 30, 1989, for the purpose of remodeling office space is hereby continued and reappropriated to the Court of Criminal Appeals in the original amount and for the original purpose, as adjusted by transfer, less any amount that has been expended upon the effective date of this act.

SECTION 3. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Court of Criminal Appeals by law shall be set by the Judges of the Court of Criminal Appeals. The salary of the Presiding Judge shall not exceed Eighty Thousand Two Hundred Fifty Dollars (\$80,250.00) per annum, payable monthly, and the salary of each of the four other Judges shall not exceed Seventy-seven Thousand Five Hundred Fifty Dollars (\$77,550.00) per annum, payable monthly, for the fiscal year ending June 30, 1992. The Court of Criminal Appeals for the fiscal year ending June 30, 1992, shall be subject to the following budgetary limitations, on full-time-equivalent employees and expenditures, excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 4. The appropriation and reappropriation made by this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1992. Any unexpended funds remaining

after November 15, 1992, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 5. This act shall become effective July 1, 1991.

SECTION 6. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
