EDUCATION AND TRAINING, THE MILITARY DEPARTMENT OF THE STATE OF OKLAHOMA, THE BUREAU OF NARCOTICS AND DANGEROUS DRUGS CONTROL, THE PARDON AND PAROLE BOARD, THE DEPARTMENT OF PUBLIC SAFETY, AND THE DEPARTMENT OF TRANSPORTATION; STATING THE SUMS OF THE APPROPRIATIONS; PROVIDING FOR PURPOSES SPECIFYING CERTAIN RESTRICTIONS; PROHIBITING CERTAIN TRANSFERS; AUTHORIZING CERTAIN REDUCTIONS; PROHIBITING CERTAIN EXPENDITURES; PROVIDING LAPSE DATE; MAKING CERTAIN APPROPRIATIONS NONFISCAL; AND PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Two Hundred Seventy-two Thousand Eight Hundred Eighteen Dollars (\$3,272,818.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Billion One Hundred Twenty-five Million Eight Hundred Twenty-nine Thousand Three Hundred Sixty-nine Dollars (\$1,125,829,369.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Seven Hundred Fifty-seven Thousand Five Hundred Dollars (\$1,757,500.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 4. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Million Six Hundred Fifteen Thousand Five Hundred Seventy-three Dollars (\$2,615,573.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 5. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Five Hundred Six Million One Hundred Eighty-one Thousand Four Hundred Ninety-five Dollars (\$506,181,495.00) or so much thereof as may be necessary to perform the duties imposed upon the State Regents for Higher Education by law.

SECTION 6. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Five Hundred Eighty Thousand Five Hundred Fifty-four Dollars (\$4,580,554.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 7. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from

the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Hundred Fifty-five Thousand Six Hundred Thirty-six Dollars (\$355,636.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 8. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Four Hundred Sixty-eight Thousand Seven Hundred Twenty-seven Dollars (\$4,468,727.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 9. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Depletion, Management and Sale Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Seven Hundred Eighty-seven Thousand Four Hundred Fifty-seven Dollars (\$787,457.00) and from the Depletion, Management and Sale Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Two Hundred Ninety-two Thousand Six Hundred Fifty-eight Dollars (\$3,292,658.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 10. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Five Million Eight Hundred Sixty-three Thousand Three Hundred Ninety-four Dollars (\$5,863,394.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 11. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Thirteen Thousand One Hundred Thirty-four Dollars (\$113,134.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 12. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Six Hundred Seventy-four Thousand Three Hundred Ninety-eight Dollars (\$3,674,398.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 13. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Six Million Four Hundred Seventy-two Thousand Two Hundred Fifteen Dollars (\$6,472,215.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 14. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seventy-six Million Three Hundred Sixty-five Thousand Eight Hundred Forty-six Dollars (\$76,365,846.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 15. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 1993, the sum of Five Hundred Fifteen Thousand Forty Dollars (\$515,040.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND JUDICIARY

SECTION 16. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Eight Hundred Eighty-one Thousand Six Hundred Sixty-six Dollars (\$3,881,666.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 17. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Four Hundred Eighty Thousand One Hundred Forty-five Dollars (\$3,480,145.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 18. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Hundred Seventy-three Thousand Two Hundred Thirteen Dollars (\$273,213.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 19. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 1993, the sum of Fifty Thousand Dollars (\$50,000.00) or so much thereof as may be necessary to provide uniform computer systems development including computer software, for county government in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 20. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Thirty-two Thousand Four Hundred Twenty-four Dollars (\$132,424.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for Capitol Improvements to the Capitol buildings.

SECTION 21. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Eighty-five Thousand Dollars (\$85,000.00) or so much thereof as may be necessary for vacant office space rental expenses in the State Office Buildings in Tulsa, Oklahoma, to be transferred to the Operational Fund for State Office Buildings, Tulsa, of the Capitol Improvement Authority.

SECTION 22. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Twenty-three Million One Hundred Ten Thousand Nine Hundred Sixty-nine Dollars (\$23,110,969.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys and District Attorneys Council by law.

SECTION 23. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Six Hundred Eighty-six Thousand Forty Dollars (\$1,686,040.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 24. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Thirteen Million Six Hundred Twenty-seven Thousand Five Hundred Eleven Dollars (\$13,627,511.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 25. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Eight Million Two Hundred Seventy-four Thousand Five Hundred Dollars (\$8,274,500.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 26. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Five Million Three Hundred Ten Thousand Two Hundred One Dollars (\$5,310,201.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 27. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Four Hundred Thousand Dollars

(\$1,400,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 28. There is hereby appropriated to the State Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Hundred Six Thousand Two Hundred Eighty-seven Dollars (\$306,287.00) or so much thereof as may be necessary to perform the duties imposed upon the State Ethics Commission by law.

SECTION 29. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Nine Million Four Hundred Fifty-five Thousand Six Hundred Eight Dollars (\$9,455,608.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 30. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the amount of Four Hundred Ninety-nine Thousand Thirteen Dollars (\$499,013.00) or so much thereof as may be necessary to pay assessments for the following intergovernmental agencies:

If funds appropriated in this section are insufficient to pay the total assessments for the organizations named herein, the payment to each organization, except the National Conference of State Legislatures, shall be reduced proportionally to bring the total payments within the limits of the funds appropriated herein.

SECTION 31. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the following amount or so much thereof as may be required for the following purposes:

SECTION 32. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the amount of Eleven Million Four Hundred Eleven Thousand Five Hundred Fourteen Dollars (\$11,411,514.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives,

the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses.

SECTION 33. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1991, the sum of Two Hundred Fifty Thousand Dollars (\$250,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and Supplements.

SECTION 34. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1991, the amount of One Million One Hundred Thirty Thousand Two Hundred Fifty-one Dollars (\$1,130,251.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 35. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the amount of Three Million Five Thousand Nine Hundred Fifteen Dollars (\$3,005,915.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 36. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the amount of Four Hundred Forty-four Thousand Seven Hundred Sixty Dollars (\$444,760.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 37. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal

year ending June 30, 1993, the sum of Five Hundred Twenty-three Thousand One Hundred Thirty-four Dollars (\$523,134.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 38. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the Cash-Flow Reserve Fund of the State Treasury, designated by the Office of State Finance as the "091 Fund", the sum of Fifteen Thousand Dollars (\$15,000.00) or so much thereof as may be necessary for legal services when the Attorney General disqualifies himself from legal counsel or representation of the Oklahoma Merit Protection Commission due to conflict of interest. These funds shall be expended exclusively for this purpose and shall not be transferable.

SECTION 39. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Four Hundred Thirty-nine Thousand Five Hundred Forty-two Dollars (\$4,439,542.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 40. There is hereby appropriated to the Office of Public Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Ten Million Fifty-six Thousand Three Hundred One Dollars (\$10,056,301.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Public Affairs by law.

SECTION 41. There is hereby appropriated to the Office of Public Affairs from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seven Hundred Forty-one Thousand

Five Hundred Twenty-three Dollars (\$741,523.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Public Affairs by law.

SECTION 42. There is hereby appropriated to the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Hundred Ninety-eight Thousand Three Hundred Seventeen Dollars (\$398,317.00) or so much thereof as may be necessary to perform the duties imposed upon the Secretary of State by law.

SECTION 43. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of their employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personal services

(including retirement and insurance costs), including those of members and employees of the Senate, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals and for the renovation and modification of the Senate area

SECTION 44. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Eighty-nine Thousand Four Hundred Fifty-five Dollars (\$4,089,455.00) or so much thereof as may be required to perform the duties imposed upon the State Supreme Court and the Court of Appeals by law.

SECTION 45. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the Workers' Compensation Fund of the State Treasury for the fiscal year ending June 30, 1993, the amount of Two Million Seven Hundred Seventy-two Thousand Eight Hundred Sixty-one Dollars (\$2,772,861.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court or Court of Appeals by law.

SECTION 46. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Forty-two Million Two Hundred Eighty-four Thousand Twenty-eight Dollars (\$42,284,028.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 47. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary to improve the revenue estimating system of the State of Oklahoma.

SECTION 48. There is hereby appropriated to the Oklahoma Tax Commission for transfer to the Fund for Reimbursement of Counties from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Six Hundred Forty-seven Thousand Five Hundred Forty-three

Dollars (\$647,543.00) or so much thereof as may be necessary to reimburse the counties for revenue lost because of the homestead exemption provided for by Section 2407.1 of Title 68 of the Oklahoma Statutes. No monies shall be disbursed to any county that is not in compliance with the assessment requirements mandated by the Supreme Court of the State of Oklahoma in State ex rel. Poulos v. State Board of Equalization, 646 P.2d 1269, 1273 (Okla. 1982).

SECTION 49. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Ninety-seven Thousand Five Hundred Fifty Dollars (\$3,097,550.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Treasurer by law.

SECTION 50. There is hereby appropriated to the State Land Reimbursement Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1991, the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary to make payments to counties for agricultural land free of homesteads which is owned by the state as school or park land.

SECTION 51. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Two Hundred Thousand Dollars (\$1,200,000.00) or so much thereof as may be necessary to pay for bank service charges. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 52. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury

for the fiscal year ending June 30, 1993, the sum of Three Million One Hundred Sixty-eight Thousand Eight Hundred Twenty-four Dollars (\$3,168,824.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SUBCOMMITTEE ON HEALTH AND SOCIAL SERVICES

SECTION 53. There is hereby appropriated to the Commission on Children and Youth from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Two Hundred Ninety-three Thousand One Hundred Forty-three Dollars (\$1,293,143.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on Children and Youth by law.

SECTION 54. There is hereby appropriated to the Office of Handicapped Concerns from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Hundred Ninety-five Thousand Two Hundred Eighty-seven Dollars (\$295,287.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Handicapped Concerns by law.

There is hereby appropriated to the State Department of Health from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Forty-eight Million Three Hundred Four Thousand Two Hundred Seventy-five Dollars (\$48,304,275.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

SECTION 56. There is hereby appropriated to the Human Rights Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seven Hundred Three Thousand One Hundred Fifty Dollars (\$703,150.00) or so much thereof as may be

necessary to perform the duties imposed upon the Human Rights Commission by law.

SECTION 57. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Six Hundred Eighteen Million Two Hundred Twenty-four Thousand Nine Hundred Seventy-six Dollars (\$618,224,976.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

There is hereby appropriated to the Indian Affairs Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Ninety-two Thousand One Hundred Seventy Dollars (\$192,170.00) or so much thereof as may be necessary to perform the duties imposed upon the Indian Affairs Commission by law.

SECTION 59. There is hereby appropriated to the J.D. McCarty Center for Handicapped Children from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seven Hundred Fifty-one Thousand Seven Hundred Seventeen Dollars (\$751,717.00) or so much thereof as may be necessary to perform the duties imposed upon the J.D. McCarty Center for Handicapped Children by law.

SECTION 60. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Million Three Hundred Sixty-one Thousand Seven Hundred Fifty-four Dollars (\$2,361,754.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 61. There is hereby appropriated to the Department of Mental Health and Substance Abuse Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Four Million One Hundred Ninety-five Thousand Five Hundred Sixty-eight Dollars (\$104,195,568.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Mental Health and Substance Abuse Services by law.

SECTION 62. There is hereby appropriated to the Oklahoma Department of Veterans Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Fifteen Million Six Hundred Twenty-seven Thousand Nine Hundred Eighty-two Dollars (\$15,627,982.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Veterans Affairs by law.

There is hereby appropriated to the Oklahoma Conservation Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Seven Hundred Seventy-six Thousand Four Hundred Thirty-four Dollars (\$4,776,434.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Conservation Commission by law.

SECTION 67. There is hereby appropriated to the Commission on Consumer Credit from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seven Hundred Four Thousand Five Hundred Seventy-three Dollars (\$704,573.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on Consumer Credit by law.

SECTION 68. There is hereby appropriated to the Corporation Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Seven Hundred Seventy-four Thousand Eight Hundred Fifty-three Dollars (\$4,774,853.00) or so much thereof as may be necessary to perform the duties imposed upon the Corporation Commission by law.

SECTION 69. There is hereby appropriated to the Oklahoma Horse Racing Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Million Four Hundred Eighty-

four Thousand Six Hundred Two Dollars (\$2,484,602.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Horse Racing Commission by law.

SECTION 70. There is hereby appropriated to the State Insurance Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Million Six Hundred Eighteen Thousand Six Hundred Eighty-one Dollars (\$2,618,681.00) or so much thereof as may be necessary to perform the duties imposed upon the State Insurance Department by law.

SECTION 76. There is hereby appropriated to the Oklahoma Securities Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Eight Hundred Sixteen Thousand Three Hundred Seventy-eight Dollars (\$816,378.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Securities Commission by law.

SECTION 77. There is hereby appropriated to the Oklahoma Tourism and Recreation Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Twenty-two Million Five Hundred Seventy-nine Thousand Seven Hundred Ninety-three Dollars (\$22,579,793.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tourism and Recreation Department by law.

SECTION 82. There is hereby appropriated to the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Nine Hundred Twenty-two Thousand Nine Hundred

Eighty Dollars (\$922,980.00) or so much thereof as may be necessary to perform the duties imposed upon the State Fire Marshal by law.

SECTION 83. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Seven Million Six Hundred Seventy-nine Thousand Four Hundred Thirty Dollars (\$7,679,430.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law.

SECTION 84. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 1993, the sum of One Million Six Hundred Seventy-eight Thousand Four Hundred Fourteen Dollars (\$1,678,414.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 85. There is hereby appropriated to the Council on Law Enforcement Education and Training from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Hundred Twenty-three Thousand One Hundred Forty-two Dollars (\$323,142.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 86. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Nine Hundred Forty-one Thousand Four Hundred Fifty Dollars (\$3,941,450.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 87. There is hereby appropriated to the Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Six Hundred Eleven Thousand Three Hundred Ninety-nine Dollars (\$3,611,399.00) or so much thereof as may be necessary to perform the duties imposed upon the Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 88. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Million Four Hundred Twenty-one Thousand Three Hundred Sixty-nine Dollars (\$1,421,369.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 89. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Forty-eight Million Seven Hundred Fifty-four Thousand Thirty Dollars (\$48,754,030.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 90. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of One Hundred Ninety-five Million Four Hundred Fifty-eight Thousand Two Hundred Twenty-five Dollars (\$195,458,225.00). Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 91. The appropriations made by Sections 1, 4, 6, 7, 8, 10, 11, 12, 13, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 28, 29, 30, 34, 37, 38, 39, 40, 42, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88 and 89 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1993. Any unexpended funds remaining after November 15, 1993, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 92. The appropriations made by Sections 2, 3, 5, 9, 14, 26, 27, 31, 32, 33, 35, 36, 41, 43 and 90 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 93. This act shall become effective July 1, 1992.
