LIMITING THE SALARY OF THE DIRECTOR; PROVIDING BUDGETARY LIMITATIONS; AUTHORIZING CERTAIN FULL-TIME-EQUIVALENT EMPLOYEES; LIMITING CERTAIN EXPENDITURES; MAKING AN APPROPRIATION TO THE OKLAHOMA CENTER FOR THE ADVANCEMENT OF SCIENCE AND TECHNOLOGY; STATING PURPOSE; REQUIRING THE DEPOSIT OF CERTAIN MONIES IN CERTAIN REVOLVING FUNDS; PROVIDING FOR DUTIES AND COMPENSATION OF EMPLOYEES; LIMITING THE SALARY OF THE PRESIDENT OR ACTING PRESIDENT; PROVIDING BUDGETARY LIMITATIONS; LIMITING CERTAIN EXPENDITURES; MAKING AN APPROPRIATION TO THE PHYSICIAN MANPOWER TRAINING COMMISSION; STATING PURPOSE; PROVIDING FOR DUTIES AND COMPENSATION OF EMPLOYEES; LIMITING THE SALARY OF THE EXECUTIVE DIRECTOR; PROVIDING BUDGETARY LIMITATIONS; LIMITING CERTAIN EXPENDITURES; MAKING AN APPROPRIATION TO THE OKLAHOMA SCHOOL OF SCIENCE AND MATHEMATICS; STATING PURPOSE; PROVIDING FOR DUTIES AND COMPENSATION OF EMPLOYEES; LIMITING THE SALARY OF THE DIRECTOR; PROVIDING BUDGETARY LIMITATIONS; AUTHORIZING ADDITIONAL EMPLOYEES UNDER CERTAIN CONDITIONS; STATING LEGISLATIVE INTENT; LIMITING CERTAIN EXPENDITURES; MAKING APPROPRIATIONS TO THE OKLAHOMA STATE REGENTS FOR HIGHER EDUCATION; STATING PURPOSES; LIMITING CERTAIN EXPENDITURES; PROVIDING LAPSE DATE; MAKING CERTAIN APPROPRIATIONS NONFISCAL; PROVIDING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

OKLAHOMA EDUCATIONAL TELEVISION AUTHORITY

SECTION 1. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Two Million Six Hundred Fifteen Thousand Five Hundred Seventy-three Dollars (\$2,615,573.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 2. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law shall be set by the Director. The salary of the Director shall not exceed Fifty-one Thousand Eight Hundred Twenty Dollars (\$51,820.00) per annum, payable monthly for the fiscal year ending June 30, 1993. The Oklahoma Educational Television Authority for the fiscal year ending June 30, 1993, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

OKLAHOMA HISTORICAL SOCIETY

SECTION 4. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Million Five Hundred Eighty Thousand Five Hundred Fifty-four Dollars (\$4,580,554.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 5. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Historical Society by law shall be set by the Director. The salary of the Director shall not exceed Fifty-two Thousand Four Hundred Dollars (\$52,400.00) per annum, payable monthly for the fiscal year ending June 30, 1993. The Oklahoma Historical Society for the fiscal year ending June 30, 1993, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

COMMISSIONERS OF THE LAND OFFICE

SECTION 7. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Depletion, Management and Sale Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Seven Hundred Eighty-seven Thousand Four Hundred Fifty-seven Dollars (\$787,457.00) and from the Depletion, Management and Sale Fund of the State Treasury

for the fiscal year ending June 30, 1993, the sum of Three Million Two Hundred Ninety-two Thousand Six Hundred Fifty-eight Dollars (\$3,292,658.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 8. The Commissioners of the Land Office shall expend the funds appropriated in Section 7 of this act in the following categories and amounts:

SECTION 9. The salary of the Assistant Secretary shall not exceed ninety percent (90%) of the Secretary's salary per annum, payable monthly for the fiscal year ending June 30, 1993. SECTION 14. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Six Million Four Hundred Seventy-two Thousand Two Hundred Fifteen Dollars (\$6,472,215.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 15. From the monies appropriated to the Oklahoma Center for the Advancement of Science and Technology by Section 14 of this act, the following amounts shall be deposited into the Research Support Revolving Fund created pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes or so much thereof as may be necessary for the following purposes:

SECTION 20. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Physician Manpower Training Commission by law shall be set by the Physician Manpower Training Commission. The salary of the Executive Director shall not exceed Forty-one Thousand Eight Hundred Twenty Dollars (\$41,820.00) per annum, payable monthly for the fiscal year ending June 30, 1993. OKLAHOMA SCHOOL OF SCIENCE AND MATHEMATICS

SECTION 22. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Six Hundred Seventy-four Thousand Three Hundred Ninety-eight Dollars (\$3,674,398.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma School of Science and Mathematics by law. None of the monies appropriated pursuant to this section shall be used for capital expenditures.

SECTION 23. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma School of Science and Mathematics by law shall be set by the Director. The salary of the Director shall not exceed Fifty-six Thousand Eight Hundred Twenty Dollars (\$56,820.00) per annum, payable monthly for the fiscal year ending June 30, 1993. The Oklahoma School of Science and Mathematics for the fiscal year ending June 30, 1993, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 24. In addition to the full-time-equivalent employees authorized in Section 23 of this act, the Oklahoma School of Science and Mathematics is hereby authorized to employ seven (7) additional employees contingent on the receipt of federal funds. All such positions shall be terminated concurrent with the termination of such federal funds.

SECTION 25. It is the intent of the Legislature that the number of students served through the 1992-93 school year shall not exceed one hundred fifty (150) full-time students.

SECTION 26. It is the intent of the Legislature that through the 1992-93 school year the full-time-equivalent employee limit for personnel shall not exceed the budget limitations set in Section 23 of this act.

SECTION 27. It is the intent of the Legislature that of the full-time-equivalent employees in Section 23 of this act, seven instructors shall be paid on a ten-month contract.

SECTION 28. Expenditures by the Board of Trustees of the Oklahoma School of Science and Mathematics from all sources of revenue during the fiscal year ending June 30, 1993, excluding expenditures for capital and special projects, shall not exceed the following:

OKLAHOMA STATE REGENTS FOR HIGHER EDUCATION

SECTION 29. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Four Hundred Seventy-nine Million Six Hundred Eighty-eight Thousand Seven Hundred Eighty-five Dollars (\$479,688,785.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution to the institutions in The Oklahoma State System of Higher Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repair administered by the Oklahoma State Regents for Higher Education.

SECTION 30. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Three Million Seven Hundred Forty-five Thousand Seven Hundred Forty-three Dollars (\$3,745,743.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 31. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Twelve Million Two Hundred Eighty-two Thousand Nine Hundred Sixty-seven Dollars (\$12,282,967.00) or so much thereof as may be necessary for Oklahoma Tuition Aid Grants.

SECTION 32. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Five Million Four Hundred Sixty-seven Thousand Dollars (\$5,467,000.00) to be transferred to the Oklahoma State Regents' Academic Scholars Trust Fund.

SECTION 33. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of Five Million Dollars (\$5,000,000.00) to be transferred to the Oklahoma State Regents' Endowment Trust Fund.

SECTION 34. The appropriations made by Sections 1, 4, 11, 14 and 19 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1993. Any unexpended funds remaining after November 15, 1993, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 35. The appropriations made by Sections 7, 22, 29, 30, 31, 32, and 33 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the effective date of this act.

SECTION 36. This act shall become effective July 1, 1992.

SECTION 37. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
