A RESOLUTION DECLARING APRIL 2, 1991, AS INTERNATIONAL STUDENT AWARENESS DAY; COMMENDING ALL PERSONS INVOLVED IN INTERNATIONAL STUDENT PROGRAMS AND RECOGNIZING INTERNATIONAL STUDENTS; AND DIRECTING DISTRIBUTION.

WHEREAS, numerous families, schools, universities and organizations in the State of Oklahoma are serving as hosts to international students from all areas of the world; and

WHEREAS, the hospitality extended by our fellow Oklahomans enables international students to learn about our great state and nation and allows all citizens of this state to become better informed about the cultures of other countries; and

WHEREAS, the citizens of the State of Oklahoma appreciate the wonderful opportunity these students have given us to share our friendship with them and to increase our awareness and understanding of their cultures and customs; and

WHEREAS, we recognize that the knowledge we gain from these international students and the relationships we build today will become the foundation for increased world peace and harmony; and

WHEREAS, the Oklahoma House of Representatives wishes to show its appreciation to these international students for choosing to be guests of the citizens of the State of Oklahoma and to thank our fellow Oklahomans who are involved with international student programs.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 43RD OKLAHOMA LEGISLATURE:

THAT April 2, 1991, be declared as International Student Awareness Day.

THAT the Oklahoma House of Representatives commend all persons involved in international student programs of this state and recognize the many international students who have chosen to share their lives with the citizens of the State of Oklahoma.

THAT copies of this resolution be distributed by the Cochairmen of the Joint Special Committee on International Development to the international students who are guests of the Oklahoma State Legislature on this International Student Awareness Day.
