A RESOLUTION RELATING TO THE STATE PLAN FOR SERVICES TO CHILDREN, YOUTH, AND FAMILIES; PLEDGING SUPPORT; AND DIRECTING DISTRIBUTION.

WHEREAS, the welfare, of children, youth, and families is a priority for the State of Oklahoma; and

WHEREAS, the Oklahoma State Legislature directed the Oklahoma Commission on Children and Youth and local community boards to write a state plan for children, youth, and family services; and

WHEREAS, the state plan was completed January 1992; and

WHEREAS, "Children: Oklahoma's Gift to Tomorrow, A State Plan for Services to Children, Youth, and Families, 1992-1995" provides a blueprint for legislative and administrative change in regard to Oklahoma's children, youth, and families; and

WHEREAS, the House of Representatives recognizes and applauds the volunteer commitment and investment of over 1,000 Oklahoma citizens from communities across the state.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 43RD OKLAHOMA LEGISLATURE:

THAT the Oklahoma State House of Representatives pledges support for "Children: Oklahoma's Gift to Tomorrow, A State Plan for Services to Children, Youth, and Families, 1992-1995" and to continued improvement in programs that serve the children of this state.
