A RESOLUTION DESIGNATING THE MONTH OF MARCH 1992, AS PROFESSIONAL SOCIAL WORK MONTH AND REQUESTING COMMUNITY SUPPORT FOR CERTAIN PROGRAMS, CEREMONIES AND ACTIVITIES.

WHEREAS, families are the first providers of basic social services and the foundation upon which all individuals develop their skills to lead productive and satisfying lives; and

WHEREAS, families are the strength of each and every nation; and

WHEREAS, everywhere, the strength of families is challenged by lack of resources and by common problems such as sinking economies, controlled dangerous substances, AIDS, lack of adequate housing, and lack of quality education; and

WHEREAS, weakened families take their toll not only on family members, but on each society as a whole; and

WHEREAS, one weakened society affects all others; and

WHEREAS, a traditional value of the social work profession is to recognize the interdependence between individuals and their families, between families and their nations' resources and between nations; and

WHEREAS, professional social workers have been actively involved in organizing programs to improve the strength of families worldwide.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 43RD OKLAHOMA LEGISLATURE:

THAT the Oklahoma House of Representatives hereby designates the month of March 1992, as "Professional Social Work Month" in the State of Oklahoma, and calls upon members of the community to join with the social work profession in support of appropriate programs, ceremonies and activities designed to achieve its goals.
