AN ACT RELATING TO GENERAL APPROPRIATIONS FOR THE EXPENSES OF VARIOUS AGENCIES OF THE EXECUTIVE, LEGISLATIVE AND JUDICIAL DEPARTMENTS OF THE STATE; MAKING AN APPROPRIATION TO THE OKLAHOMA CENTER FOR THE ADVANCEMENT OF SCIENCE AND TECHNOLOGY, THE REGENTS FOR HIGHER EDUCATION, THE OKLAHOMA HISTORICAL SOCIETY, THE STATE BOARD OF EDUCATION, THE STATE BOARD OF VOCATIONAL TECHNICAL EDUCATION, THE OFFICE OF THE STATE AUDITOR AND INSPECTOR, THE STATE ELECTION BOARD, THE OFFICE OF THE ATTORNEY GENERAL, THE OKLAHOMA APPELLATE PUBLIC DEFENDER SYSTEM, THE COURT OF CRIMINAL APPEALS, THE STATE SUPREME COURT, THE OFFICE OF PUBLIC AFFAIRS, THE DEPARTMENT OF HUMAN SERVICES, THE DEPARTMENT OF MENTAL HEALTH AND SUBSTANCE ABUSE SERVICES, THE STATE DEPARTMENT OF HEALTH, THE OKLAHOMA DEPARTMENT OF VETERANS AFFAIRS, THE DEPARTMENT OF COMMERCE, THE OKLAHOMA TOURISM AND RECREATION DEPARTMENT, THE OKLAHOMA WATER RESOURCES BOARD, THE STATE DEPARTMENT OF AGRICULTURE, THE OKLAHOMA SECURITIES COMMISSION AND THE DEPARTMENT OF CORRECTIONS; STATING THE SUMS OF APPROPRIATIONS; PROVIDING LAPSE DATE; AND PROVIDING AN OPERATIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Six Million Seven Hundred Ninety-eight Thousand Four Hundred Sixty-six Dollars (\$6,798,466.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 2. There is hereby appropriated to the Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Five Hundred Eight Million Seven Hundred Twenty-one Thousand Eighty-one Dollars (\$508,721,081.00) or so much thereof as may be required to perform the duties imposed upon the Regents for Higher Education by law.

SECTION 3. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 1992, the sum of Three Million Five Hundred Forty-two Thousand Eight Hundred Eight Dollars (\$3,542,808.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of One Billion Eighty-seven Million Fifty-three Thousand Four Hundred Ninety-five Dollars (\$1,087,053,495.00) or so much thereof as may be required to perform the duties imposed upon the State Board of Education by law.

SECTION 5. There is hereby appropriated to the State Board of Vocational Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Seventy-four Million Two Hundred Seventy-nine Thousand Twenty-five Dollars (\$74,279,025.00) or so much thereof as may be required to perform the duties imposed upon the State Board of Vocational Technical Education by law.

SECTION 6. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Three Million Eight Hundred Eighteen Thousand Two Hundred Seventy-three Dollars (\$3,818,273.00) or so much thereof as may be required to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 7. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Five Million Ninety-nine Thousand Eight Hundred Sixteen Dollars (\$5,099,816.00) or so much thereof as may be required to perform the duties imposed upon the State Election Board by law.

SECTION 8. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Four Million Forty-one Thousand Seven Hundred Forty-five Dollars (\$4,041,745.00) or so much thereof as may be required to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 9. There is hereby appropriated to the Oklahoma Appellate Public Defender System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of One Million Eighty-eight Thousand Two Hundred Twenty-six Dollars (\$1,088,226.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Appellate Public Defender System by law.

SECTION 10. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of One Million Six Hundred Fifty-three Thousand Nine Hundred Eighty-four Dollars (\$1,653,984.00) or so much thereof as may be required to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 11. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Twelve Million Four Hundred Thirty-one Thousand Four Hundred Thirty-four Dollars (\$12,431,434.00) or so much thereof

as may be required to perform the duties imposed upon the District Courts by law.

There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund, for the fiscal year ending June 30, 1992, the sum of Nine Million Five Hundred Forty-seven Thousand Three Hundred Ten Dollars (\$9,547,310.00) or so much thereof as may be required to perform the duties imposed upon the District Courts by law.

SECTION 12. There is hereby appropriated to the Office of Public Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Eleven Million One Hundred Ninety-five Thousand Eight Hundred Eighty-eight Dollars (\$11,195,888.00) or so much thereof as may be required to perform the duties imposed upon the Office of Public Affairs by law.

SECTION 13. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Six Million Eight Hundred Forty-six Thousand Two Hundred Thirty-three Dollars (\$6,846,233.00) or so much thereof as may be required to perform the duties imposed upon the State Supreme Court and the Court of Appeals by law.

There is hereby appropriated to the State Supreme Court from the Workers' Compensation Administrative Fund for the fiscal year ending June 30, 1992, the sum of Five Hundred Seventy-two Thousand Nine Hundred seven Dollars (\$572,907.00) or so much thereof as may be required to perform the duties imposed upon the State Supreme Court and the Court of Appeals by law.

SECTION 14. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Six Hundred Ten Million Seven Hundred Thirty-nine Thousand Eighty-six Dollars (\$610,739,086.00) or so much thereof as may be required to perform the duties imposed upon the Department of Human Services by law.

SECTION 15. There is hereby appropriated to the Department of Mental Health and Substance Abuse Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of One Hundred Four Million Four Hundred Twenty-eight Thousand Three Hundred Thirty-eight Dollars (\$104,428,338.00) or so much thereof as may be required to perform the duties imposed upon the Department of Mental Health and Substance Abuse Services by law.

SECTION 16. There is hereby appropriated to the State Department of Health from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Forty-seven Million Five Hundred Sixty-nine Thousand Eight Hundred Twenty-two Dollars (\$47,569,822.00) or so much thereof as may be required to perform the duties imposed upon the State Department of Health by law.

SECTION 17. There is hereby appropriated to the Oklahoma Department of Veterans Affairs from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Sixteen Million Four Hundred Forty-one Thousand Four Hundred Ninety-six Dollars (\$16,441,496.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Department of Veterans Affairs by law.

SECTION 18. There is hereby appropriated to the Department of Commerce from any monies not otherwise appropriated from the General

Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Twelve Million Seven Hundred Thirty-two Thousand Eight Hundred Sixty-three Dollars (\$12,732,863.00) or so much thereof as may be required to perform the duties imposed upon the Department of Commerce by law.

SECTION 19. There is hereby appropriated to the Oklahoma Tourism and Recreation Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Twenty-three Million Six Hundred Sixty-three Thousand Eighty-nine Dollars (\$23,663,089.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Tourism and Recreation Department by law.

SECTION 20. There is hereby appropriated to the Oklahoma Water Resources Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Three Million Five Hundred Twelve Thousand Thirty-two Dollars (\$3,512,032.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Water Resources Board by law.

SECTION 21. There is hereby appropriated to the State Department of Agriculture from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Fourteen Million Four Hundred Ninety-nine Thousand Seven Hundred Forty-two Dollars (\$14,499,742.00) or so much thereof as may be required to perform the duties imposed upon the State Department of Agriculture by law.

SECTION 22. There is hereby appropriated to the Oklahoma Securities Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Eight Hundred Twenty-four Thousand Eight Hundred Forty-two Dollars (\$824,842.00) or so much thereof as may be required to perform the duties imposed upon the Oklahoma Securities Commission by law.

SECTION 23. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of One Hundred Fifty-three Million Three Hundred Fifty-six Thousand Six Hundred Thirty-three Dollars (\$153,356,633.00) or so much thereof as may be required to perform the duties imposed upon the Department of Corrections by law.

SECTION 24. The appropriations made by Section 3 and Sections 6 through 23 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1992. Any unexpended funds remaining after November 15, 1991, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 25. The appropriations made by Sections 1, 2, 4 and 5 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 26. This act shall become operative July 1, 1991.
