AN ACT RELATING TO THE CONSTITUTIONAL RESERVE FUND; MAKING APPROPRIATIONS TO THE OKLAHOMA STATE REGENTS FOR HIGHER EDUCATION; STATING PURPOSES; REQUIRING TRANSFER OF FUNDS TO OKLAHOMA STATE REGENTS ENDOWMENT TRUST FUND; MAKING AN APPROPRIATION TO THE STATE BOARD OF VOCATIONAL AND TECHNICAL EDUCATION; MAKING AN APPROPRIATION TO THE STATE AUDITOR AND INSPECTOR; REQUIRING TRANSFER OF FUNDS TO THE COMPUTER-ASSISTED MASS APPRAISAL IMPLEMENTATION REVOLVING FUND; MAKING AN APPROPRIATION TO THE STATE EMERGENCY FUND; MAKING APPROPRIATIONS TO THE DEPARTMENT OF HUMAN SERVICES; MAKING AN APPROPRIATION TO THE DEPARTMENT OF AGRICULTURE; MAKING AN APPROPRIATION TO THE OKLAHOMA TOURISM AND RECREATION DEPARTMENT; MAKING APPROPRIATIONS TO THE OKLAHOMA WATER RESOURCES BOARD; MAKING APPROPRIATIONS NONFISCAL; PROVIDING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Twenty Million Dollars (\$20,000,000.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution to the institutions of The Oklahoma State System of Higher Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 2. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Four Million Two Hundred Thousand Dollars (\$4,200,000.00) or so much thereof as may be necessary for the purpose of capital outlay for institutions which are not beneficiaries of the Section 13 and New College Trust Funds.

SECTION 3. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Two Million Five Hundred Thousand Dollars (\$2,500,000.00) to be transferred to the Oklahoma State Regents' Endowment Trust Fund.

SECTION 4. There is hereby appropriated to the State Board of Vocational and Technical Education for any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Two Million Dollars (\$2,000,000.00) or so much thereof as may be necessary to purchase equipment.

SECTION 5. There is hereby appropriated to the State Auditor and Inspector from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to implement under the direction of the Ad Valorem Task Force the visual inspection program and the computer-assisted system of mass appraisal. The monies appropriated by this section shall be transferred to the Computer-Assisted Mass Appraisal Implementation Revolving Fund as established in Section 2947 of Title 68 of the Oklahoma Statutes.

SECTION 6. There is hereby appropriated to the State Emergency Fund created pursuant to Section 139.42 of Title 62 of the Oklahoma Statutes from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Five Hundred Thousand Dollars (\$500,000.00) for state emergencies.

SECTION 7. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Twenty-two Million Eighty-eight Thousand Six Hundred Thirty Dollars (\$22,088,630.00) or so much thereof as may be necessary to provide funding for hospital services, prescription drugs, nursing facility services, and intermediate care facility services for the mentally retarded for the State Medicaid program.

SECTION 8. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to implement a Medicaid managed care program upon recommendation by the Interim Task Force on State Medicaid and Welfare Reform.

SECTION 9. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Two Million Four Hundred Thousand Dollars (\$2,400,000.00) or so much thereof as may be necessary for equipment acquisitions at the Oklahoma Medical Center.

SECTION 10. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to convert the Central Oklahoma Juvenile Treatment Center into a multi-purpose juvenile services facility.

SECTION 11. There is hereby appropriated to the Department of Agriculture from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary for the purpose of funding rural fire grants.

SECTION 12. There is hereby appropriated to the Oklahoma Tourism and Recreation Department from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00) or so much thereof as may be necessary for the purpose of repairs at the Lake Murray Spillway.

SECTION 13. There is hereby appropriated to the Oklahoma Water Resources Board for transfer to the Statewide Water Development

Revolving Fund created by Section 1085.4 of Title 82 of the Oklahoma Statutes, from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of One Million Six Hundred Thirty-nine Thousand Five Hundred Forty-seven Dollars (\$1,639,547.00) for the purpose of matching United States Environmental Protection Agency capitalization grants for revolving loans for wastewater system improvements.

SECTION 14. There is hereby appropriated to the Oklahoma Water Resources Board from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary for implementation of the Federal Clean Lakes Program as authorized in Section 314 of the Federal Clean Water Act.

SECTION 15. The appropriations made by this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 16. This act shall become effective July 1, 1992.

SECTION 17. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
