AN ACT RELATING TO THE DEPARTMENT OF CORRECTIONS
AND THE PARDON AND PAROLE BOARD; AMENDING 57
O.S. 1991, SECTIONS 38, 332.4 AND 563, WHICH
RELATE TO THE REIMBURSEMENT FOR INMATES, PARDON
AND PAROLE BOARD MEMBERS, AND INMATE WORK
CENTERS; SPECIFYING AMOUNT TO BE REIMBURSED;
EXEMPTING HOURS WORKED FROM CERTAIN LIMITS;
ESTABLISHING CERTAIN REQUIREMENTS FOR SELECTION
PROCEDURES; AND DECLARING AN EMERGENCY.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 57 O.S. 1991, Section 38, is
amended to read as follows:

Section 38. The Department of Corrections shall reimburse any
county, which is required to retain an inmate pursuant to ~~this act,~~
~~for the cost of feeding of the~~ paragraph 2 of Section 37 of this
title, in an amount not to exceed Seven Dollars (\$7.00) per day for
each inmate during such period of retention. The proceeds of this
reimbursement shall be used to defray expenses of equipping and
maintaining the jail and payment of personnel. The Department of
Corrections shall reimburse the county for the actual costs paid for
any emergency medical care for physical injury or illness of the
inmate retained under this resolution if the injury or illness is
directly related to the incarceration and the county is required by
law to provide such care for inmates in the jail. The Director may
accept any inmate required to have extended medical care upon
application of the county.

SECTION 2. AMENDATORY 57 O.S. 1991, Section 332.4, is
amended to read as follows:

Section 332.4 The Chairman of the Pardon and Parole Board shall
be selected by said Board. The members of said Board shall receive
Seven Thousand Two Hundred Dollars (\$7,200.00) per annum, payable
monthly; provided, that failure on the part of any member to attend
Board meetings during any month will preclude his right to said
month's compensation except in case of justifiable cause. In
addition, the Chairman and members of said Pardon and Parole Board
shall receive expenses while attending and going to and from
meetings of the Board and in performing their official duties,
according to the State Travel Reimbursement Act. Such compensation
shall be paid by the State Treasurer by state warrant drawn against
funds appropriated for such purpose by the Legislature. Hours
worked by Board members shall be exempt from full-time-equivalent
employee limits.

SECTION 3. AMENDATORY 57 O.S. 1991, Section 563, is
amended to read as follows:

Section 563. A. Before any correctional facility other than an inmate work center as authorized in subsection B of this section, whether within the Department of Corrections or within any other state agency, may be created or any construction performed which may significantly increase, extend or expand the present facility, such creation or construction shall be approved by the Legislature. Correctional facilities owned or operated by private prison contractors shall not be deemed to be within the Department of Corrections or other state agency.

B. The Department of Corrections is hereby authorized to establish inmate work centers, not to exceed one hundred (100) inmates, in locations where a need for labor to conduct public work projects is determined. ~~Said work centers shall be established~~ The Department shall select the inmate work center locations based on objective comparisons of interested communities in accordance with procedures and criteria established by the Department of Corrections. The procedures, selection criteria and decision case analysis shall be made available to the public upon request.

SECTION 4. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
