EDUCATION AND TRAINING, THE MILITARY DEPARTMENT OF THE STATE OF OKLAHOMA, THE BUREAU OF NARCOTICS AND DANGEROUS DRUGS CONTROL, THE PARDON AND PAROLE BOARD, THE DEPARTMENT OF PUBLIC SAFETY, AND THE DEPARTMENT OF TRANSPORTATION; STATING THE SUMS OF THE APPROPRIATIONS; PROVIDING LAPSE DATE; MAKING CERTAIN APPROPRIATIONS NONFISCAL; PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Cashflow Reserve Fund designated by the Office of State Finance as the "091" Fund, the sum of \_\_\_\_ Dollars (\$\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the

Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of \_\_\_ Dollars (\$\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 6. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 7. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Regents for Higher Education by law.

SECTION 8. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 9. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 10. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 11. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Depletion Management and Sales Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 12. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Depletion Management and Sales Fund for the fiscal year ending June 30, 1992, the sum of \_\_\_ Dollars (\$\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 13. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 14. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars

(\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 15. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 16. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 17. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 18. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SECTION 22. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to provide uniform computer systems development including computer software, for county government in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 23. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for Capitol Improvements to the Capitol buildings.

SECTION 24. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1993, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary for vacant office space rental expenses in the State Office Buildings in Tulsa, Oklahoma, to be transferred to the Operational Fund for State Office Buildings, Tulsa, of the Capitol Improvement Authority.

SECTION 97. The appropriations made by Sections 2, 3, 5, 7, 14, 17, 29, 30, 34, 35, 36, 38, 39, 46 and 95 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.
