AS INTRODUCED

A CONCURRENT RESOLUTION EXPRESSING THE LEGISLATIVE INTENT
OF SENATE BILL NO. 862 CONCERNING THE ISSUING OF
ORGANIZATION LICENSE FOR NON-PARI-MUTUEL TRACKS; AND
DIRECTING DISTRIBUTION.

WHEREAS, the 1st Session of the Oklahoma Legislature enacted
House Bill No. 1261, which abolished the Oklahoma Horse Racing
Commission's authority and responsibility for issuing organization
licenses to applicants to conduct non-pari-mutuel racing or
accredited work or training races; and

WHEREAS, the 2nd Session of the 43rd Legislature enacted Senate
Bill No. 862, thereby re-establishing the Oklahoma Horse Racing
Commission's authority and responsibility to issue organization
licenses to applicants to conduct non-pari-mutuel racing or
accredited work or training races; and

WHEREAS, Senate Bill No. 862 was enacted with an emergency
clause, and thereby became immediately effective upon signing by the
Governor on March 26, 1992.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION
OF THE 43RD OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES
CONCURRING THEREIN:

THAT it is the intent of the Oklahoma Legislature in enacting Senate Bill No. 862 that the Oklahoma Horse Racing Commission issue an organization license to conduct non-pari-mutuel race meetings and training races held at non-pari-mutuel tracks to any applicant who:

1. Had an organization license issued by the Oklahoma Horse Racing Commission to conduct horse racing without the pari-mutuel system of wagering during the twelve (12) months preceding the effective date of Senate Bill No. 892; and

2. Has submitted an application to the Oklahoma Horse Racing Commission for an organization license to conduct non-pari-mutuel race meetings and training races held at non-pari-mutuel tracks for the 1992 calendar year; and

3. Has not been denied an organization license to conduct non-pari-mutuel race meetings and training races held at non-pari-mutuel tracks by the Oklahoma Horse Racing Commission in the manner provided by law during the five-day period following the effective date of Senate Bill No. 862.

THAT copies of this resolution be distributed to the Governor and the Chairman and the Executive Director of the Oklahoma Horse Racing Commission.
