An Act relating to education; amending Section 14 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, which relates to appropriation to the Physician Manpower Training Commission; modifying such appropriation; making appropriation to the Physician Manpower Training Commission; stating purpose; amending Section 9 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, which relates to expenditure of monies appropriated to the Physician Manpower Training Commission; modifying such expenditures; amending Section 13 of Enrolled House Bill No. 1829 of the 1st Session of the 44th Oklahoma Legislature, which relates to the Oklahoma Historical Society; modifying budgetary limitations; amending Section 23 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, which relates to the Board of Vocational and Technical Education; modifying certain expenditures; amending Section 10 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, as amended by Section 12 of Enrolled House Bill No. 1829 of the 1st Session of the 44th Oklahoma Legislature, which relates to appropriation to the Oklahoma Historical Society; modifying such appropriation; modifying designation of such monies; making appropriation to the Oklahoma Historical Society; stating purpose; modifying such expenditures; amending Section 7 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, as amended by Section 2 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, which relates to appropriation to the State Regents for Higher Education; modifying such appropriation; making appropriation to the Oklahoma State Regents for Higher Education; stating purposes; amending Section 7 of Enrolled House Bill No. 1828 of the 1st Session of the 44th Oklahoma Legislature, which relates to appropriation to the State Board of Education; modifying source of such appropriation; specifying fiscal year of such appropriation; correcting cite; amending Section 4 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, which relates to legislative intent concerning allocations by the Oklahoma State Regents for Higher Education; modifying such intent;

amending Section 5 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, which relates to legislative intent concerning allocations by the Oklahoma State Regents for Higher Education; modifying such intent; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 14 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 14. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of ~~Five Million Five Hundred Fifty-four Thousand Seven Hundred Ninety-five Dollars (\$5,554,795.00)~~ Five Million Three Hundred Fifty-four Thousand Seven Hundred Ninety-five Dollars (\$5,354,795.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 2. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Two Hundred Thousand Dollars (\$200,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 3. AMENDATORY Section 9 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 9. The ~~amount~~ amounts appropriated in Section 14 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, as amended by Section 1 of this act, and in Section 2 of this act, shall be expended as follows:

SECTION 4. AMENDATORY Section 13 of Enrolled House Bill No. 1829 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 13. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Historical Society by law shall be set by the Director. The salary of the Director shall not exceed Fifty-five Thousand Twenty Dollars (\$55,020.00) per annum, payable monthly for the fiscal year ending June 30, 1994. The Oklahoma Historical Society for the fiscal year ending June 30, 1994, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

Section 12. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of ~~Four Million Three Hundred Four Thousand Four Hundred Sixty-seven Dollars (\$4,304,467.00)~~ Four Million Two Hundred Four Thousand Four Hundred Sixty-seven Dollars (\$4,204,467.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 8. The amount appropriated in Section 12 of Enrolled House Bill No. 1829 of the 1st Session of the 44th Oklahoma Legislature, as amended by Section 6 of this act, and in Section 7 of this act, shall be expended as follows:

SECTION 9. AMENDATORY Section 7 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, as amended by Section 2 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 2. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of ~~Five Hundred Fourteen Million Three Hundred Ninety-nine Thousand Nine Hundred Twenty-four Dollars (\$514,399,924.00)~~ Five Hundred Four Million One Hundred Thirteen Thousand Five Hundred Fifty-one Dollars (\$504,113,551.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Regents for Higher Education by law.

SECTION 10. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Ten Million Two Hundred Eighty-Six Thousand Three Hundred Seventy-three Dollars (\$10,286,373.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Regents for Higher Education by law.

SECTION 11. AMENDATORY Section 7 of Enrolled House Bill No. 1828 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the ~~Special Cash Fund~~ General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994 the sum of Ten Million Two

Hundred Eighty-six Thousand Three Hundred Seventy-three Dollars (\$10,286,373.00) or so much thereof as may be necessary to accomplish the support of public school activities by law as provided for in paragraph 2 of Section 19 of ~~this act~~ Enrolled House Bill No. 1828 of the 1st Session of the 44th Oklahoma Legislature.

SECTION 12. AMENDATORY Section 4 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 4. It is the intent of the Legislature that of the funds appropriated in Section ~~2 of this act~~ 10 of Enrolled House Bill No. 1757 of the 1st Session of the 44th Oklahoma Legislature for the duties imposed upon the Oklahoma State Regents for Higher Education by law, Five Million Dollars (\$5,000,000.00) be allocated by the Oklahoma State Regents for Higher Education and transferred to the Oklahoma State Regents' Endowment Trust Fund.

SECTION 13. AMENDATORY Section 5 of Enrolled Senate Bill No. 574 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 5. It is the intent of the Legislature that of the funds appropriated in Section ~~2 of this act~~ 9 and Section 10 of Enrolled House Bill No. 1757 of the 1st Session of the 44th Oklahoma Legislature for the duties imposed upon the Oklahoma State Regents for Higher Education by law, Five Million Four Hundred Sixty-seven Thousand Dollars (\$5,467,000.00) be allocated by the Oklahoma State Regents for Higher Education and transferred to the Oklahoma State Regents' Academic Scholars Trust Fund.

SECTION 14. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
