An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the State Regents for Higher Education, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the State Board of Vocational and Technical Education, the Will Rogers Memorial Commission, the Office of the Attorney General, the Office of the State Auditor and Inspector, the Oklahoma Capitol Improvement Authority, the Court of Criminal Appeals, the State Supreme Court, the State Election Board, the State Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Oklahoma Indigent Defense System, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Office of Personnel Management, the Department of Central Services, the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of State Treasurer, the State Land Reimbursement Fund, the Workers' Compensation Court, the Commission on Children and Youth, the Office of Handicapped Concerns, the State Department of Health, the Human Rights Commission, the Department of Human Services, the Indian Affairs Commission, the J.D. McCarty Center for Handicapped Children, the Board of Medicolegal Investigations, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the State Banking Department, the Oklahoma Department of Commerce, the Oklahoma Conservation Commission, the Commission on Consumer Credit, the Corporation Commission, the Department of Environmental

Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Liquefied Petroleum Gas Board, the Department of Mines, the Oklahoma Securities Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Alcoholic Beverage Laws Enforcement Commission, the Civil Emergency Management Administration, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Military Department of the State of Oklahoma, the Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety and the Department of Transportation; stating sums of the appropriations; stating purposes and restrictions; providing lapse date; making certain appropriations nonfiscal; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Million One Hundred Thousand Five Hundred Sixty-five Dollars (\$3,100,565.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Billion Two Hundred Fifty-one Million Three Hundred Forty Thousand One Hundred Fifteen Dollars (\$1,251,340,115.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Two Hundred Ten Thousand One Hundred Sixty-seven Dollars (\$1,210,167.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Fourteen Million Four Hundred Fifty-one Thousand Four Hundred Seventy-six Dollars (\$14,451,476.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Fourteen Million Nine Hundred Fifty Thousand Sixty-six Dollars (\$14,950,066.00) or so much thereof as

may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 6. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Two Million Four Hundred Seventy-seven Thousand Nine Hundred Twelve Dollars (\$2,477,912.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 7. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Hundred Seventy-six Million Three Hundred Ninety-one Thousand Two Hundred Ninety-seven Dollars (\$476,391,297.00) or so much thereof as may be necessary to perform the duties imposed upon the State Regents for Higher Education by law.

SECTION 8. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Fifteen Million Dollars (\$15,000,000.00) or so much as thereof as may be necessary for the duties imposed upon the State Regents for Higher Education.

SECTION 9. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Million Two Hundred Sixty-five Thousand Nine Hundred Twelve Dollars (\$3,265,912.00) or so much as thereof as may be necessary for the general operating budget of the Administrative Offices of the State Regents for Higher Education.

SECTION 10. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Million Three Hundred Forty-three Thousand Seventy-two Dollars (\$4,343,072.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 11. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Hundred Thirty-six Thousand Nine Hundred Nineteen Dollars (\$336,919.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 12. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Million Two Hundred Thirty-three Thousand Five Hundred Thirty-one Dollars (\$4,233,531.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 13. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Million Seven Hundred Seventy-seven Thousand Four Hundred Forty-five Dollars (\$4,777,445.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 14. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Five Million Five Hundred Fifty-four Thousand Seven Hundred Ninety-five Dollars (\$5,554,795.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 15. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Hundred Seven Thousand One Hundred Seventy-nine Dollars (\$107,179.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 16. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Million Four Hundred Eighty-one Thousand Eight Dollars (\$3,481,008.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 17. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Million Five Hundred Eighty-one Thousand Five Hundred Seventy-two Dollars (\$6,581,572.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 18. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Seventy-nine Million Seven Hundred Sixty-one Dollars (\$79,000,761.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 19. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Hundred Eighty-seven Thousand Nine Hundred Thirty-two Dollars (\$487,932.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND JUDICIARY

SECTION 20. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Million Five Thousand One Dollars (\$4,005,001.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 21. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Million Six Hundred Eighteen Thousand Nine Hundred Thirty-two Dollars (\$3,618,932.00) or so much thereof as may be necessary to perform

the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 22. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Two Hundred Five Thousand Nine Hundred Eighty Dollars (\$205,980.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for Capitol Improvements to the Capitol buildings.

SECTION 23. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Twenty-two Million Five Hundred Thirty-seven Thousand Eight Hundred Seventy-three Dollars (\$22,537,873.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys and District Attorneys Council by law.

SECTION 24. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Six Hundred Sixty-eight Thousand Three Hundred Eighty-four Dollars (\$1,668,384.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 25. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Sixteen Million Sixteen Thousand Four Hundred Dollars (\$16,016,400.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 26. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Million Five Hundred Eighteen Thousand Forty-five Dollars (\$6,518,045.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 27. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Three Thousand Six Hundred Sixty-two Dollars (\$3,662.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 28. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Million Six Hundred Thirty-eight Thousand Four Hundred Ninety Dollars (\$6,638,490.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 29. There is hereby appropriated to the State Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Hundred Thousand Eight Hundred Eleven Dollars (\$300,811.00) or so much thereof as may be necessary to perform the duties imposed upon the State Ethics Commission by law.

SECTION 30. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June

30, 1994, the sum of Nine Million One Hundred Fourteen Thousand One Hundred Eighty-six Dollars (\$9,114,186.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 31. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the following amount or so much thereof as may be required for the following purposes:

SECTION 32. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of Eleven Million Four Hundred Thirty-two Thousand One Hundred Seventy-eight Dollars (\$11,432,178.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses.

SECTION 33. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of Eight Million Three Hundred Eighty-seven Thousand Three Hundred Twenty-nine Dollars (\$8,387,329.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 34. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of Two Million Eight Hundred Forty-seven Thousand Seven Hundred Nine Dollars (\$2,847,709.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 35. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of Four Hundred Twenty-one Thousand Three Hundred Fifty-one Dollars (\$421,351.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 36. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Five Hundred Thirty-six Thousand Eight Hundred Eleven Dollars (\$536,811.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 37. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from

the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Four Million Three Hundred Ten Thousand Six Hundred Ninety-three Dollars (\$4,310,693.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 38. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Nine Million Three Hundred Forty-eight Thousand Two Hundred Seventeen Dollars (\$9,348,217.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 39. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Eight Hundred Ninety Thousand Three Hundred One Dollars (\$890,301.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 40. There is hereby appropriated to the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Hundred Thirty-four Thousand Seven Hundred Fifty-three Dollars (\$634,753.00) or so much thereof as may be necessary to perform the duties imposed upon the Secretary of State by law.

SECTION 41. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of their employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

SECTION 42. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the Workers' Compensation Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of Six Million Nine Hundred Forty-seven Thousand Seven Hundred Seventeen Dollars (\$6,947,717.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court or Court of Appeals by law.

SECTION 43. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Forty-one Million Six Hundred Sixty-six Thousand Seven Hundred Fifty-two Dollars (\$41,666,752.00)

or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 44. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Two Million Eight Hundred Seventy-six Thousand One Hundred Dollars (\$2,876,100.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Treasurer by law.

SECTION 45. There is hereby appropriated to the State Land Reimbursement Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Ninety Thousand Dollars (\$90,000.00) or so much thereof as may be necessary to make payments to counties for agricultural land free of homesteads which is owned by the state as school or park land.

SECTION 46. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Two Hundred Thousand Dollars (\$1,200,000.00) or so much thereof as may be necessary to pay for bank service charges. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 47. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Hundred Forty-four Thousand Four Hundred Eighty-five Dollars (\$644,485.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 48. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Two Million Four Hundred Thirty-eight Thousand Twenty-five Dollars (\$2,438,025.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SUBCOMMITTEE ON HEALTH AND SOCIAL SERVICES

SECTION 49. There is hereby appropriated to the Commission on Children and Youth from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Two Hundred Eighty-one Thousand Three Hundred Thirty-three Dollars (\$1,281,333.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on Children and Youth by law.

SECTION 50. There is hereby appropriated to the Office of Handicapped Concerns from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Two Hundred Ninety-seven Thousand Seven Hundred Forty-five Dollars (\$297,745.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Handicapped Concerns by law.

SECTION 51. There is hereby appropriated to the State Department of Health from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Forty Million Four Hundred Sixty-six Thousand Two Hundred Eight-three Dollars (\$40,466,283.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

SECTION 52. There is hereby appropriated to the Human Rights Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Hundred Sixty-six Thousand One Hundred Forty-two Dollars (\$666,142.00) or so much thereof as may be necessary to perform the duties imposed upon the Human Rights Commission by law.

SECTION 53. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Six Hundred Three Million Two Hundred Sixty-eight Thousand One Hundred Ninety-seven Dollars (\$603,268,197.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

SECTION 54. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1992, the sum of Thirteen Million Eight Hundred Nineteen Thousand Four Hundred Twenty Dollars (\$13,819,420.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Human Services by law.

SECTION 55. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Three Hundred Seventy-seven Thousand Three Hundred Seventy-four Dollars (\$1,377,374.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Hundred Seventy-four Million One Hundred Twenty-nine Thousand Fifty-seven Dollars (\$174,129,057.00), or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 93. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the Transportation Fund of the State Treasury for the fiscal year ending

June 30, 1992, the sum of Five Million Six Hundred Fifty-eight Thousand Twenty-eight Dollars (\$5,658,028.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 94. The appropriations made by Sections 1, 5, 6, 10, 11, 12, 13, 14, 15, 16, 17, 19, 20, 21, 22, 23, 24, 25, 26, 27, 29, 30, 33, 36, 37, 38, 39, 40, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90 and 91 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1994. Any unexpended funds remaining after November 15, 1994, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 95. The appropriations made by Sections 2, 3, 4, 7, 8, 9, 18, 28, 31, 32, 34, 35, 41, 53, 54, 55, 92 and 93 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 96. This act shall become effective July 1, 1993.
