An Act relating to sunset; amending 74 O.S. 1991, Section 3906, as last amended by Section 357 of Enrolled House Bill No. 1002 of the 1st Session of the 44th Oklahoma Legislature, which relates to the 1993 list of sunset entities; modifying the sunset date for such entities; correcting names of certain entities; correcting cite; amending 74 O.S. 1991, Section 3912, which relates to recommendations of the Sunset Review Committee; and eliminating mandatory recommendation date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 1991, Section 3906, as last amended by Section 357 of Enrolled House Bill No. 1002 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 3906. The following statutory entities and their successors shall be terminated on July 1, ~~1993~~ 1999, and all powers, duties and functions shall be abolished one (1) year thereafter:

1. State Board of Registration for Foresters as created by Section 1203 of Title 59 of the Oklahoma Statutes;

2. Polygraph Examiners Board as created by Section 1455 of Title 59 of the Oklahoma Statutes;

3. State Board of Medical Licensure and Supervision as created by Section 481 of Title 59 of the Oklahoma Statutes;

4. State Board of Osteopathy Osteopathic Examiners as created by Section 624 of Title 59 of the Oklahoma Statutes;

5. Board of Chiropractic Examiners as created by Section ~~161~~ 161.4 of Title 59 of the Oklahoma Statutes; and

6. ~~Oklahoma State Board of Podiatry~~ Podiatric Medical Examiners as created by Section 137 of Title 59 of the Oklahoma Statutes.

SECTION 2. AMENDATORY 74 O.S. 1991, Section 3912, is amended to read as follows:

Section 3912. If an entity is recommended by the review committee to be terminated, continued, modified or consolidated, the review committee shall submit to the State Legislature a recommendation for the termination, re-creation, specific modifications to be made, or for the orderly transfer of such functions, powers, duties and personnel, if any, to such other governmental entity as the review committee determines could most efficiently carry out such functions, powers and duties. ~~Such recommendation shall be made on or before January 1 prior to the date of termination as set out in Sections 3903 through 3908 of this title.~~
