An Act relating to funding for state legislative entities; amending Section 32 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, which relates to appropriations made to the House of Representatives; modifying appropriation amount; making an appropriation to the House of Representatives; stating purposes; requiring approval of certain claims; authorizing the Legislative Service Bureau to pay Energy Council assessment from certain appropriated monies, with limitation; stating purposes; making appropriations nonfiscal; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

HOUSE OF REPRESENTATIVES

SECTION 1. AMENDATORY Section 32 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, is amended to read as follows:

Section 32. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of ~~Eleven Million Four Hundred Thirty-two Thousand One Hundred Seventy-eight Dollars (\$11,432,178.00)~~ Eleven Million Eighty-two Thousand One Hundred Seventy-eight Dollars (\$11,082,178.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses.

SECTION 2. There is hereby appropriated to the House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and supplements.

SECTION 3. Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 1994, shall be approved by the Speaker of the House of Representatives.

LEGISLATIVE SERVICE BUREAU

SECTION 4. The Legislative Service Bureau is hereby authorized to pay, from monies appropriated by Section 34 of Enrolled Senate Bill No. 383 of the 1st Session of the 44th Oklahoma Legislature, an

amount not to exceed Thirty-two Thousand Dollars (\$32,000.00) as the State of Oklahoma assessment for the Energy Council (formerly the Southwest Regional Energy Council).

SECTION 5. The appropriations made by Sections 1 and 2 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 6. This act shall become effective September 1, 1993.
