HOUSE BILL NO. 1329

AS INTRODUCED

An Act relating to counties and county officers;  
amending 19 O.S. 1991, Section 180.62, which  
relates to basic salaries; providing for uniform  
salaries; providing for maximum salary within  
group; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 19 O.S. 1991, Section 180.62, is amended to read as follows:

Section 180.62 A. The basic salaries of county officers upon which all salaries and future increases or decreases thereof shall be computed, shall be as follows:

1. In every county having a net valuation of all tangible taxable property, as defined in Sections 180.58 and 180.59 of this title, of Twenty Million Dollars (\$20,000,000.00) or less, the basic salary of each of the county officers named in group "A" shall be Thirteen Thousand Eight Hundred Fifty Dollars (\$13,850.00) per annum, and the basic salary of each of the county officers named in group "B" shall be Thirteen Thousand Four Hundred Sixty Dollars (\$13,460.00) per annum;

2. In every county having a net valuation of all tangible taxable property, as defined in Sections 180.58 and 180.59 of this

title, of more than Twenty Million Dollars (\$20,000,000.00) but not more than Thirty Million Dollars (\$30,000,000.00), the basic salary of each of the county officers named in group "A" shall be Fifteen Thousand Four Hundred Forty-five Dollars (\$15,445.00) per annum, and the basic salary of the county officers named in group "B" shall be Fourteen Thousand Nine Hundred Seventy Dollars (\$14,970.00) per annum;

3. In every county having a net valuation of all tangible taxable property, as defined in Sections 180.58 and 180.59 of this title, of more than Thirty Million Dollars (\$30,000,000.00) but not more than Forty Million Dollars (\$40,000,000.00), the basic salary of each of the county officers named in group "A" shall be Sixteen Thousand Seven Hundred Twenty Dollars (\$16,720.00) per annum, and the basic salary of each of the county officers named in group "B" shall be Fifteen Thousand Six Hundred Sixty-five Dollars (\$15,665.00) per annum;

4. In every county having a net valuation of all tangible taxable property, as defined in Sections 180.58 and 180.59 of this title, of more than Forty Million Dollars (\$40,000,000.00) but not more than Fifty Million Dollars (\$50,000,000.00), the basic salary of each of the county officers named in group "A" shall be Seventeen Thousand Eight Hundred Thirty-five Dollars (\$17,835.00) per annum, and the basic salary of each of the county officers named in group "B" shall be Fifteen Thousand Nine Hundred Twenty-five Dollars (\$15,925.00) per annum; and

5. In every county having a net valuation of all tangible taxable property, as defined in Sections 180.58 and 180.59 of this title, of more than Fifty Million Dollars (\$50,000,000.00), the basic salary of each of the county officers named in group "A" shall be Eighteen Thousand Seven Hundred Ninety Dollars (\$18,790.00) per annum, and the basic salary of each of the county officers named in

group "B" shall be Sixteen Thousand Eight Hundred Eighty Dollars (\$16,880.00) per annum.

B. In all counties of this state, the total annual salaries of each of the county officers named in group "C" shall be fixed by the board of county commissioners except where otherwise provided by law, and in each county the salary last fixed by the board of county commissioners before the election or appointment of any such officer shall be the applicable salary for such county officer for the ensuing term.

C. The annual salaries fixed by this act shall be paid either monthly or twice a month, by order of the board of county commissioners, for each month or fraction thereof the incumbent lawfully occupies and holds title to such office.

D. The salaries of all county officers in groups "A" and "B" within each county shall be uniform within each of the groups and shall be determined as follows:

1. The salaries of each county officer shall be individually computed pursuant to the provisions of this section and Section 180.63 of this title;

2. The salaries of all county officers in their respective groups "A" and "B" shall be the highest salary computed for any county officer, in the respective group, in the county, pursuant to the provisions of this section and Section 180.63 of this title.

SECTION 2. This act shall become effective September 1, 1993.
