AS INTRODUCED

An Act relating to general appropriations for the expenses of various agencies of the Executive, Legislative and Judicial Departments of the State; making an appropriation to the State Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the State Regents for Higher Education, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the State Board of Vocational and Technical Education, the Will Rogers Memorial Commission, the Office of the Attorney General, the Office of the State Auditor and Inspector, the Oklahoma Capitol Improvement Authority, the Court of Appeals, the State Supreme Court, the State Election Board, the State Ethics Commission, the

Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Oklahoma Indigent Defense System, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Office of Personnel Management, the Department of Central Services, the Secretary of State, the State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the State Land Reimbursement Fund, the Workers' Compensation Court, the Commission on Children and Youth, the Office of Handicapped Concerns, the State Department of Health, the Human Rights Commission, the Department of Human Services, the Indian Affairs Commission, the J.D. McCarty Center for Handicapped Children, the Board of Medicolegal Investigations, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the State Banking Department, the Department of Commerce, the Oklahoma Conservation Commission, the Commission on Consumer Credit, the Corporation Commission, the Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Liquefied Petroleum Gas Board, the Department of Mines, the Pollution Control Coordinating Board, the Oklahoma Securities Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Alcoholic Beverage Laws Enforcement Commission, the Civil Emergency Management Administration, the Department of Corrections, the

State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Military Department of the State of Oklahoma, the Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, and the Department of Transportation; stating the sums of the appropriations; providing for purposes specifying certain restrictions; prohibiting certain transfers; authorizing certain reductions; prohibiting certain expenditures; providing lapse date; making certain appropriations nonfiscal; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 3. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 4. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Regents for Higher Education by law.

SECTION 5. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 6. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 7. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 8. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 9. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 10. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 11. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 12. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to

perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 13. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 14. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND JUDICIARY

SECTION 15. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 16. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 17. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for Capitol Improvements to the Capitol buildings.

SECTION 18. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary for vacant office space rental expenses in the State Office Buildings in Tulsa, Oklahoma, to be transferred to the Operational Fund for State Office Buildings, Tulsa, of the Capitol Improvement Authority.

SECTION 19. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys and District Attorneys Council by law.

SECTION 20. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 21. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 22. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State

Judicial Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 23. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 24. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 25. There is hereby appropriated to the State Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Ethics Commission by law.

SECTION 26. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 27. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the amount of _____ Dollars (\$_____.00) or so much

thereof as may be necessary to pay assessments for the following intergovernmental agencies:

SECTION 33. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated

from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 34. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary for legal services when the Attorney General disqualifies herself from legal counsel or representation of the Oklahoma Merit Protection Commission due to conflict of interest. SECTION 42. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 43. There is hereby appropriated to the Oklahoma Tax Commission for transfer to the Fund for Reimbursement of Counties from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to reimburse the counties for revenue lost because of the homestead exemption provided for by Section 2407.1 of Title 68 of the Oklahoma Statutes. No monies shall be disbursed to any county that is not in compliance with the assessment requirements mandated by the Supreme Court of the State of Oklahoma in State ex rel. Poulos v. State Board of Equalization, 646 P.2d 1269, 1273 (Okla. 1982).

SECTION 46. There is hereby appropriated to the Office of the State Treasurer from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to pay for bank service charges. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 47. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

There is hereby appropriated to the Commission on Children and Youth from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on Children and Youth by law.

Any unexpended funds remaining after November 15, 1994, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 91. The appropriations made by Sections 2, 4, 13, 23, 24, 28, 29, 31, 32, 39, 52, 88 and 89 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 92. This act shall become effective July 1, 1993.
