AS INTRODUCED

A Concurrent Resolution commending the life and career of the late State Senator Robert C. Lollar; and directing distribution.

WHEREAS, Robert C. Lollar was born in Picher, Oklahoma, on August 8, 1924. On May 17, 1948, he married Eunice French after serving in the United States Air Force from 1943 to 1946. Robert C. Lollar graduated from the University of Oklahoma Law School in 1950, after undergraduate work at Northeastern State University in Tahlequah, Oklahoma; and

WHEREAS, Robert C. Lollar practiced law in Miami, Oklahoma, beginning in 1950. He served as city judge in Miami from 1951 to 1953 and then again from 1955 to 1957. He was an assistant county attorney of Ottawa County in 1954; and

WHEREAS, Robert C. Lollar served in the Oklahoma House of Representatives from 1957 to 1960 where he was Assistant Majority Floor Leader in 1959. He was elected to the Oklahoma State Senate where he served in the 28th and 29th Legislatures from 1961 to 1965; and

WHEREAS, in 1965 he was appointed by Governor Henry Bellmon to lead a bipartisan committee to study and recommend changes to Oklahoma's election laws and processes. He also served as an aide to Governor Dewey Bartlett and worked as the Governor's legislative

liaison from 1967 to 1970. He was appointed as a Regent for the University of Oklahoma in 1970; and

WHEREAS, Robert C. Lollar was a member of numerous civic, religious and professional organizations, such as the Veterans of Foreign Wars (VFW), the American Legion, the Masonic Lodge and the Junior Chamber of Commerce (JayCees). He taught nondenominational bible study since 1982. Robert C. Lollar and his wife, Eunice, had two daughters, a son and twelve grandchildren; and

WHEREAS, Robert C. Lollar died at the age of 69 years on Thursday, March 24, 1994.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 44TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma State Legislature commends the life and career of the late State Senator Robert C. Lollar.
