AS INTRODUCED

A Joint Resolution disapproving rules of the Oklahoma Tax Commission relating to charity games; directing distribution; and declaring an emergency.

WHEREAS, on March 23, 1993, the Oklahoma Tax Commission issued Order No. 93-03-23-015 adopting permanent Rule Nos. 710:95-7-1 through 710:95-7-15, 710:95-7-20 through 710:95-7-24, 710:95-7-30 through 710:95-7-33, 710:95-7-40 through 710:95-7-42, 710:95-7-50, 710:95-7-51 and 710:95-7-100 relating to miscellaneous areas of regulatory and administrative authority with respect to charity games; and

WHEREAS, on March 24, 1993, the Oklahoma Tax Commission submitted for consideration by the Legislature permanent Rule Nos. 710:95-7-1 through 710:95-7-15, 710:95-7-20 through 710:95-7-24, 710:95-7-30 through 710:95-7-33, 710:95-7-40 through 710:95-7-42, 710:95-7-50, 710:95-7-51 and 710:95-7-100 relating to miscellaneous areas of regulatory and administrative authority with respect to charity games; and

WHEREAS, the Oklahoma Tax Commission had previously issued Order Nos. 92-12-01-010, 92-12-08-011, 93-02-11-020 and 93-03-18-003 adopting emergency Rule Nos. 710:95-7-1 through 710:95-7-25 relating to miscellaneous areas of regulatory and administrative authority with respect to charity games; and

WHEREAS, such rules do not reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 44TH OKLAHOMA LEGISLATURE:

SECTION 1. Oklahoma Tax Commission permanent Rules 710:95-7-1 through 710:95-7-15, 710:95-7-20 through 710:95-7-24, 710:95-7-30 through 710:95-7-33, 710:95-7-40 through 710:95-7-42, 710:95-7-50, 710:95-7-51 and 710:95-7-100 relating to miscellaneous areas of regulatory and administrative authority with respect to charity games which were adopted by the Oklahoma Tax Commission on March 23, 1993, by Order No. 93-03-23-015 are hereby disapproved by the Oklahoma State Legislature.

SECTION 2. Oklahoma Tax Commission emergency Rules 710:95-7-1 through 710:95-7-25 relating to miscellaneous areas of regulatory and administrative authority with respect to charity games which were adopted by the Oklahoma Tax Commission by Order Nos. 92-12-01-010, 92-12-08-011, 93-02-11-020 and 93-03-18-003 are hereby disapproved by the Oklahoma State Legislature.

SECTION 3. The Secretary of State is hereby directed to distribute copies of this resolution to the Governor, the Oklahoma Tax Commission and the editor of "The Oklahoma Register".

SECTION 4. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this resolution shall take effect and be in full force from and after its passage and approval.
