CONFERENCE COMMITTEE SUBSTITUTE

An Act relating to historical preservation; making an appropriation to the Oklahoma Historical Society; stating purposes; providing for duties and compensation of employees; limiting the salary of the Director; providing budgetary limitations; expanding purposes for which specific previously appropriated money may be expended; making an appropriation to the J.M. Davis Memorial Commission; stating purpose; providing for duties and compensation of employees; limiting the salary of the Chief Administrative Officer; providing budgetary limitations; expanding purposes for which specific previously appropriated money may be expended; making an appropriation to the Will Rogers Memorial Commission; stating purpose; providing for duties and compensation of employees; providing budgetary limitations; expanding purposes for which specific previously appropriated money may be expended; providing lapse dates; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

OKLAHOMA HISTORICAL SOCIETY

SECTION 1. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Hundred Ninety-four Thousand One Hundred Sixty-seven Dollars (\$194,167.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 2. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Historical Society by law shall be set by the Director of the Oklahoma Historical Society. The salary of the Director shall not exceed Fifty-five Thousand Eight Hundred Twenty Dollars (\$55,820.00) per annum, payable monthly for the fiscal year ending June 30, 1996. The Oklahoma Historical Society for the fiscal year ending June 30, 1996, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 3. Funds appropriated to the Oklahoma Historical Society in Sections 1, 4 and 5, Chapter 246, O.S.L. 1994 may be budgeted and expended for the fiscal year ending June 30, 1996, and may be budgeted and expended for the general operations of the Oklahoma Historical Society regardless of the purpose for which the funds were budgeted by the agency for the fiscal year ending June 30, 1995.

J.M. DAVIS MEMORIAL COMMISSION

SECTION 4. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Thirteen Thousand Four Hundred Eighty Dollars (\$13,480.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 5. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law shall be set by the Chief Administrative Officer of the J.M. Davis Memorial Commission. The salary of the Chief Administrative Officer shall not exceed Forty-one Thousand One Hundred Twenty-eight Dollars

(\$41,128.00) per annum, payable monthly for the fiscal year ending June 30, 1996. The J.M. Davis Memorial Commission for the fiscal year ending June 30, 1996, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 6. Funds appropriated to the J. M. Davis Memorial Commission in Section 6, Chapter 246, O.S.L. 1994 may be budgeted and expended for the fiscal year ending June 30, 1996, and may be budgeted and expended for the general operations of the J. M. Davis Memorial Commission regardless of the purpose for which the funds were budgeted by the agency for the fiscal year ending June 30, 1995.

WILL ROGERS MEMORIAL COMMISSION

SECTION 7. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Ten Thousand Dollars (\$10,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SECTION 8. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law shall be set by the Commission. The Will Rogers Memorial Commission for the fiscal year ending June 30, 1996, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 9. Funds appropriated to the Will Rogers Memorial Commission in Section 8, Chapter 246, O.S.L. 1994 may be budgeted and expended for the fiscal year ending June 30, 1996, and may be budgeted and expended for the general operations of the Will Rogers Memorial Commission regardless of the purpose for which the funds were budgeted by the agency for the fiscal year ending June 30, 1995.

SECTION 10. The appropriations made by this act to state agencies for the operations of state government may be budgeted for the fiscal year ending June 30, 1996 (hereafter FY-96) or may be budgeted for the fiscal year ending June 30, 1997 (hereafter FY-97). Funds budgeted for FY-96 may be encumbered only through June 30, 1996, and must be expended by November 15, 1996. Any funds remaining after November 15, 1996, and not budgeted for FY-97, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-97 may be encumbered only through June 30, 1997. Any funds remaining after November 15, 1997, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-96, and not required to pay obligations for that fiscal year, may be budgeted for FY-97, after the agencies have prepared and submitted a budget work program revision removing these funds from the FY-96 budget work program and after such revision has been approved by the Office of State Finance.

SECTION 11. This act shall become effective September 1, 1995.
