BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

COURT OF CRIMINAL APPEALS

SECTION 1. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of _____ Dollars (\$_____.00) or so much thereof as may be required to perform the duties imposed upon the Court of Criminal Appeals by law.

DISTRICT COURTS

SECTION 2. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SUPREME COURT

SECTION 3. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General

Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court and the Court of Appeals by law.

SECTION 4. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of _____ Dollars (\$_____.00) or so much thereof as may be necessary to pay the operating expenses of the Court on the Judiciary.

SECTION 5. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of _____ Dollars (\$_____.00) or so much thereof as may be necessary to pay the operating expenses of the Judicial Nominating Commission.

WORKERS' COMPENSATION COURT

SECTION 6. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administrative Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of _____ Dollars (\$_____.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 7. The appropriations made by this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1996. Any unexpended funds remaining after November 15, 1996, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 8. This act shall become effective July 1, 1995.

SECTION 9. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby

declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
