WHEREAS, pursuant to subsection G of Section 308 of Title 75 of the Oklahoma Statutes, the Legislature may waive the thirty-legislative-day review period for any rule which has been transmitted for legislative review; and

WHEREAS, on or about May 17, 1996, pursuant to Article I of the Oklahoma Administrative Procedures Act, the Board of Regents of Oklahoma Colleges submitted to the Legislature for review proposed amendments, additions and revocations to proposed permanent rules
