A Joint Resolution disapproving certain rules of the Wildlife Conservation Commission relating to citizen complaints of employee actions; disapproving emergency and permanent rules OAC 800:1-10-1, OAC 800:1-10-2, OAC 800:1-10-3, OAC 800:1-10-4, OAC 800:1-10-5, OAC 800:1-10-6, and OAC 800:1-10-7; directing distribution; and declaring an emergency.

WHEREAS, pursuant to Sections 250.2 and 308 of Title 75 of the Oklahoma Statutes, the Legislature reserves the right to determine that a rule is not consistent with legislative intent and disapprove such rule or any portion thereof; and

WHEREAS, on or about August 14, 1995, the Wildlife Conservation Commission submitted proposed emergency rules to the Governor and the Legislature pursuant to the Oklahoma Administrative Procedures Act, which rules were approved by the Governor on September 21, 1995; and

WHEREAS, emergency rules OAC 800:1-10-1 through OAC 800:1-10-7, relating to citizen complaints of employee actions, do not reflect the intent of the Legislature; and

WHEREAS, on or about August 14, 1995, the Wildlife Conservation Commission submitted proposed permanent rules to the Governor and the Legislature pursuant to the Oklahoma Administrative Procedures Act, which rules were approved by the Governor on September 21, 1995; and

WHEREAS, permanent rules OAC 800:1-10-1 through OAC 800:1-10-7, relating to citizen complaints of employee actions, do not reflect the intent of the Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 2ND SESSION OF THE 45TH OKLAHOMA LEGISLATURE:

SECTION 1. The Legislature hereby disapproves Wildlife Conservation Commission emergency rules OAC 800:1-10-1 through OAC 800:1-10-7, relating to citizen complaints of employee actions.

SECTION 2. The Legislature hereby disapproves Wildlife Conservation Commission permanent rules OAC 800:1-10-1 through OAC 800:1-10-7, relating to citizen complaints of employee actions.

SECTION 3. The Secretary of State is hereby directed to distribute copies of this resolution to the Governor, the Director of the Wildlife Conservation Commission and the Editor of "The Oklahoma Register".

SECTION 4. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
