An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state and for interest on the public debt; making appropriations to the State Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Vocational and Technical Education, the Will Rogers Memorial Commission, the Office of the State Auditor and Inspector, the Oklahoma Capitol Improvement Authority, the Department of Central Services, the Civil Emergency Management Administration, the State Election Board, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the State Land Reimbursement Fund, the Office of the Attorney General, the Attorney General's Evidence Fund, the Court of Criminal Appeals, the State Supreme Court, the State Ethics Commission, the Oklahoma Indigent Defense System, the Workers' Compensation Court, the Commission on Children and Youth, the Office of Handicapped Concerns, the State Department of Health, the Human Rights Commission, the Indian Affairs Commission, the J.D. McCarty Center for Handicapped Children, the Board of Medicolegal Investigations, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the Oklahoma Health Care Authority, the Department of Human Services, the Department of Rehabilitation Services, the University Hospitals Authority, the Office of Juvenile Affairs, the

State Department of Agriculture, the Oklahoma Conservation Commission, the Liquefied Petroleum Gas Board, the Department of Mines, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the State Banking Department, the Oklahoma Department of Commerce, the Commission on Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Oklahoma Securities Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Pardon and Parole Board, the Oklahoma State Bureau of Investigation, the Office of the State Fire Marshal, the Department of Transportation, the Council on Law Enforcement Education and Training, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, and the Department of Public Safety; stating sums of appropriations; stating purposes and restrictions upon appropriations; modifying references related to school funding; providing lapse date; making certain appropriations nonfiscal; and providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Thirty-eight Thousand Thirty-seven Dollars (\$3,038,037.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Billion Three Hundred Fifty-eight Million Six Hundred Seventy-five Thousand Eight Hundred Thirty-seven Dollars (\$1,358,675,837.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. Of the funds appropriated in Section 2 of this act, the sum of Two Hundred Sixty-two Million Nine Hundred Twenty-seven Thousand Three Hundred Fifty-six Dollars (\$262,927,356.00) is from fiscal year 1996 revenues certified for appropriation by the State Board of Equalization pursuant to the provisions of Section 41.29a of Title 62 of the Oklahoma Statutes.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Million Four Hundred Seventy-two Thousand Five Hundred Dollars (\$1,472,500.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Million Two Hundred Ten Thousand Five Hundred Ninety-one Dollars (\$1,210,591.00) or so much

thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Twenty-eight Million Four Hundred Nineteen Thousand Six Hundred Fifty-four Dollars (\$28,419,654.00) or so much thereof as may be necessary to accomplish the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the sum of Fourteen Million One Hundred Fifty-eight Thousand Four Hundred Forty-one Dollars (\$14,158,441.00) or so much thereof as may be necessary for the Purchase of Textbooks.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Sixteen Million Two Hundred Thirty-eight Thousand Thirty-six Dollars (\$16,238,036.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 9. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Two Million Four Hundred Twenty-two Thousand Three Hundred Sixty-seven Dollars (\$2,422,367.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 10. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Hundred Twenty-two Million Two Hundred Sixty-one Thousand Three Hundred Seventy-two Dollars (\$522,261,372.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 11. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Four Hundred Thirty-five Thousand Four Hundred Twenty Dollars (\$3,435,420.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 12. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the sum of Five Million Eight Hundred One Thousand Dollars (\$5,801,000.00) or so much thereof as may be necessary to be transferred to the Oklahoma State Regents' Academic Scholars Trust Fund.

SECTION 13. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance

as the "094" Fund, the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to be transferred to the Oklahoma State Regents' Endowment Trust Fund.

SECTION 14. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the sum of Thirteen Million Five Hundred Thirty-seven Thousand Four Hundred Thirty Dollars (\$13,537,430.00) or so much thereof as may be necessary to be expended for Oklahoma tuition aid grants pursuant to the Oklahoma Higher Education Tuition Aid Act.

SECTION 15. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Five Hundred Seven Thousand Dollars (\$3,507,000.00) or so much thereof as may be necessary for the purpose of capital outlay for institutions which are not beneficiaries of the Section 13 and New College Trust Funds.

SECTION 16. There is hereby appropriated to the State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Million Two Hundred Fifty-two Thousand Five Hundred Dollars (\$1,252,500.00) or so much thereof as may be necessary for establishing summer academies for Oklahoma's most qualified students who have completed the seventh (7th) grade but have not completed the twelfth (12th) grade. Said academies shall be established for instruction in the areas of science and mathematics as well as in multidisciplinary studies. The State Regents shall develop the criteria for the operation of the academies. All funds used for these academies shall be awarded on a competitive basis.

SECTION 17. There is hereby appropriated to the Oklahoma Historical Society from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Four Million Three Hundred Seventy-nine Thousand Two Hundred Eleven Dollars (\$4,379,211.00) or so much thereof may be necessary to perform the duties imposed upon the Oklahoma Historical Society by law.

SECTION 18. There is hereby appropriated to the J.M. Davis Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Hundred Thirty-seven Thousand Seven Hundred Twenty-one Dollars (\$337,721.00) or so much thereof as may be necessary to perform the duties imposed upon the J.M. Davis Memorial Commission by law.

SECTION 19. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Four Million Four Hundred Sixty-six Thousand Nine Hundred Fifty-seven Dollars (\$4,466,957.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 20. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Million Twenty-two Thousand Seven Hundred Seventy Dollars (\$5,022,770.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 21. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 22. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Million Two Hundred Seventeen Thousand Six Hundred Fourteen Dollars (\$5,217,614.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 23. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Hundred Thirteen Thousand Two Hundred Twenty-six Dollars (\$113,226.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 24. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Three Hundred Ninety-seven Thousand Four Hundred Sixty-seven Dollars (\$3,397,467.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 25. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Six Million Fifty Thousand Eight Hundred Fifty-one Dollars (\$6,050,851.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 26. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Hundred Forty-six Thousand Seven Hundred Fifteen Dollars (\$146,715.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 27. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Eighty-five Million Five Hundred Forty-nine Thousand Three Hundred Sixty-one Dollars (\$85,549,361.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 28. There is hereby appropriated to the Will Rogers Memorial Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Four Hundred Ninety-one Thousand Six Hundred Forty-five Dollars (\$491,645.00) or so much thereof as may be necessary to perform the duties imposed upon the Will Rogers Memorial Commission by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT

SECTION 29. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Two Hundred Seventy-three Thousand Nine Hundred Eighty-five Dollars (\$3,273,985.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 30. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Hundred Eighty-three Thousand Five Hundred Ninety-one Dollars (\$383,591.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 31. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Forty-five Thousand Dollars (\$45,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software, for county government in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 32. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Hundred Forty Thousand Two Hundred Seventy Dollars (\$140,270.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for Capital Improvements to the Capitol buildings.

SECTION 33. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Million Twelve Thousand Six Hundred Sixty-six Dollars (\$5,012,666.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 34. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Thousand Dollars (\$5,000.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the capitol complex.

SECTION 35. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Two Hundred Thousand Dollars (\$200,000.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 36. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Million Nine Hundred Thirty-six Thousand Thirty-seven Dollars (\$3,936,037.00) to be transferred

to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 37. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of One Hundred Forty-two Dollars (\$142.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 38. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Nine Hundred Sixty-three Thousand Fifteen Dollars (\$963,015.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 39. There is hereby appropriated to the Civil Emergency Management Administration from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Four Hundred Sixty-two Thousand Eight Hundred Four Dollars (\$462,804.00) or so much thereof as may be necessary to perform the duties imposed upon the Civil Emergency Management Administration by law.

SECTION 40. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Million Eight Hundred Fourteen Thousand Six Hundred Fifty-seven Dollars (\$5,814,657.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 41. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Million Two Hundred Sixty Thousand Dollars (\$1,260,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 42. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Eight Million Eighty-six Thousand One Hundred Seventy-eight Dollars (\$8,086,178.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 43. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the amount of Six Hundred Forty-nine Thousand Three Hundred Twenty-four Dollars (\$649,324.00) or so much thereof as may be necessary to pay assessments for the following intergovernmental agencies:

If funds appropriated in this section are insufficient to pay the total assessments for the organizations named herein, the payment to each organization, except the National Conference of State Legislatures, shall be reduced proportionally to bring the total payments within the limits of the funds appropriated herein.

SECTION 44. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the following amount or so much thereof as may be required for the following purposes:

SECTION 45. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of Ten Million Nine Hundred Thirty-one Thousand One Hundred Seventeen Dollars (\$10,931,117.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 1996, shall be approved by the Speaker of the House of Representatives.

SECTION 46. There is hereby appropriated to the House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and supplements.

SECTION 47. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of Two Million Seven Hundred Ninety-nine Thousand Four Hundred Seventy-two Dollars (\$2,799,472.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 48. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the amount of Four Hundred Twelve Thousand Four Hundred Forty-four Dollars (\$412,444.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 49. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Hundred Five Thousand Seven Hundred Forty-three Dollars (\$505,743.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 50. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Fifteen Thousand Dollars (\$15,000.00) or so much thereof as may be necessary for legal services when the Attorney General is disqualified from legal counsel or representation of the Oklahoma Merit Protection Commission due to conflict of interest. These funds shall be expended exclusively for this purpose and shall not be transferable.

SECTION 51. There is hereby appropriated to the Corporation Commission from any monies not otherwise appropriated from the Cash Flow Reserve Fund designated by the Office of State Finance as the "094" Fund, the sum of Two Million Dollars (\$2,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Corporation Commission by law.

SECTION 113. There is hereby appropriated to the Corporation Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Million Six Hundred Forty-five Thousand Nine Hundred Sixty-two Dollars (\$1,645,962.00) or so much thereof as may be necessary to perform the duties imposed upon the Corporation Commission by law.

SECTION 114. There is hereby appropriated to the Department of Environmental Quality from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Seven Million Two Hundred Fourteen Thousand Nine Hundred Forty-four Dollars (\$7,214,944.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Environmental Quality by law.

SECTION 115. There is hereby appropriated to the Oklahoma Horse Racing Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of One Million Nine Hundred Seventy-two Thousand Two Hundred Eighty-five Dollars (\$1,972,285.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Horse Racing Commission by law.

SECTION 116. There is hereby appropriated to the State Insurance Department from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Two Million Four Hundred Thirty-eight Thousand Six Hundred Thirty-nine Dollars (\$2,438,639.00) or so much thereof as may be necessary to perform the duties imposed upon the State Insurance Department by law.

There is hereby appropriated to the Oklahoma Securities Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1996, the sum of Five Hundred Fourteen Thousand Four Hundred Seventy-one Dollars (\$514,471.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Securities Commission by law.

Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 126. There is hereby appropriated to the Department of Transportation from any monies not otherwise appropriated from the State Transportation Fund of the State Treasury for the fiscal year ending June 30, 1994, the sum of Seven Million Eight Hundred Fifty Thousand Five Hundred Forty-eight Dollars (\$7,850,548.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Transportation by law. Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 127. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 1996, the sum of One Million Three Hundred Seventy-eight Thousand Five Hundred Eighty-nine Dollars (\$1,378,589.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 128. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 1994, the sum of Two Hundred Sixty-four Thousand Four

Hundred Seventy-three Dollars (\$264,473.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 129. Fund for the fiscal year ending June 30, 1996, the sum of Four Hundred Two Thousand One Dollars (\$402,001.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 134. The appropriations made by Sections 1, 8, 9, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 42, 43, 49, 50, 51, 52, 53, 54, 55, 56, 58, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94, 103, 104, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121, 122, 123, 124, 127, 128, 129, 130, 131, 132 and 133 of this act shall be subject to fiscal year limitations and may be encumbered through June 30, 1996. Any unexpended funds remaining after November 15, 1996, shall lapse and be transferred to the credit of the proper fund for the then current fiscal year.

SECTION 135. The appropriations made by Sections 2, 4, 5, 6, 7, 10, 11, 12, 13, 14, 15, 16, 27, 40, 41, 44, 45, 46, 47, 48, 57, 95, 96, 97, 98, 99, 100, 101, 102, 125 and 126 of this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 136. Sections 1 and 6 through 133 of this act shall become effective July 1, 1995.

SECTION 137. Sections 2, 3, 4 and 5 of this act shall become effective August 1, 1995.
