An Act relating to the State Department of Rehabilitation Services; amending Sections 6 and 8 of Enrolled House Bill No. 1805 of the 2nd Session of the 45th Oklahoma Legislature, which relates to the State Department of Rehabilitation Services; modifying certain appropriations; modifying certain budgetary limitations; making certain appropriations to the Department of Human Services; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 6 of Enrolled House Bill No. 1805 of the 2nd Session of the 45th Oklahoma Legislature, is amended to read as follows:

Section 6. There is hereby appropriated to the State Department of Rehabilitation Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of ~~Five Hundred Eight Thousand Seven Hundred Forty-eight Dollars (\$508,748.00)~~ Six Hundred Seventy-eight Thousand Seven Hundred Forty-eight Dollars (\$678,748.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Rehabilitation Services by law.

SECTION 2. AMENDATORY Section 8 of Enrolled House Bill No. 1805 of the 2nd Session of the 45th Oklahoma Legislature, is amended to read as follows:

Section 8. For the fiscal year ending June 30, 1997, the Department of Rehabilitation Services shall budget all appropriated funds in the following categories and amounts:

For the fiscal year ending June 30, 1997, the Department of Rehabilitation Services shall budget all funds in the following categories and amounts:

Receipt and expenditure of unanticipated federal funds awarded the Department of Rehabilitation Services after July 1, 1996, shall be exempt from expenditure limitations, provided that any such funds used for operations shall be included in the agency's budget work program.

SECTION 3. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be necessary for Geriatric Day Care Services.

SECTION 4. This act shall become effective September 1, 1996.
