An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the State Board of Vocational and Technical Education, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Oklahoma Capitol Improvement Authority, the State Election Board, the State Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Office of Personnel Management, the Department of Central Services, the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Department of Civil Emergency Management, the Military Department of the State of Oklahoma, the Oklahoma Department of Commerce, the Department of Transportation, the Commission on Children and Youth, the Office of Handicapped Concerns, the Human Rights Commission, the Department of Human Services, the Department of Rehabilitation Services, the Indian Affairs Commission, the Board of Medicolegal Investigations, the Office of Juvenile Affairs, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Handicapped Children, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the State Banking Department, the Oklahoma Conservation Commission, the Corporation Commission, the Department of Environmental Quality, the

Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Department of Mines, the Oklahoma Securities Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, the State Supreme Court, the Workers' Compensation Court, and the Oklahoma Indigent Defense System; stating sums of the appropriations; stating purposes and restrictions; establishing the Medicaid Administrative Costs Fund; authorizing a lease purchase agreement; requiring legislative approval; providing lapse dates; making certain appropriations nonfiscal; requiring and prohibiting certain budgetary procedures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Thirty-six Thousand Thirty-seven Dollars (\$3,036,037.00) or so much thereof as may be necessary to perform the duties imposed upon the State Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Billion Three Hundred Seventy-four Million Eight Hundred Sixty-three Thousand Four Hundred Thirty-nine Dollars (\$1,374,863,439.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. Of the funds appropriated in Section 2 of this act, the sum of Two Hundred Seventy-six Million Six Hundred Forty-six Thousand Seven Hundred Forty Dollars (\$276,646,740.00) is from fiscal year 1997 revenues certified for appropriation by the State Board of Certification pursuant to the provisions of Section 41.29a of Title 62 of the Oklahoma Statutes.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Million Three Hundred Thousand Nine Hundred Fifty-four Dollars (\$1,300,954.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of Four Hundred Fifty-five Thousand Eight Hundred Ninety Dollars (\$455,890.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Twenty-eight Million Seven Hundred Seventy-one Thousand Seven Hundred Twelve Dollars (\$28,771,712.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Cash-flow Reserve Fund, designated by the Office of State Finance as the "095" Fund, the sum of Fourteen Million One Hundred Fifty-eight Thousand Four Hundred Forty-one Dollars (\$14,158,441.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Two Hundred Thirteen Thousand Dollars (\$213,000.00) or so much thereof as may be necessary for the duties imposed upon the Office of Accountability by law.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Fifteen Million Five Hundred Seventy-two Thousand Seven Hundred Seventy-seven Dollars (\$15,572,777.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 10. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Two Million Four Hundred Twenty-two Thousand Three Hundred Sixty-seven Dollars (\$2,422,367.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 11. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Hundred Eleven Million Three Hundred One Thousand Two Hundred One Dollars (\$511,301,201.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 12. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Five Hundred Five Thousand Three Hundred Seventy-eight Dollars (\$3,505,378.00) or so much thereof as may be necessary for the

general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 13. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Cash-flow Reserve Fund, designated by the Office of State Finance as the "095" Fund, the sum of Fifty Million Dollars (\$50,000,000.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 14. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Million Forty-one Thousand Six Hundred Twenty-five Dollars (\$5,041,625.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 15. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 16. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Four Million Eight Hundred Ninety Thousand Five Hundred Eight Dollars (\$4,890,508.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 17. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Cash-flow Reserve Fund, designated by the Office of State Finance as the "095" Fund, the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 18. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Thirteen Thousand Two Hundred Twenty-six Dollars (\$113,226.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 19. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Four Hundred Six Thousand Four Hundred Thirty-seven Dollars (\$3,406,437.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 20. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Six

Million Fifty Thousand Eight Hundred Fifty-one Dollars (\$6,050,851.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 21. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Eighty-seven Million Seven Hundred Sixty Thousand Eight Hundred Ninety-eight Dollars (\$87,760,898.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SECTION 22. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Forty-six Thousand Seven Hundred Fifteen Dollars (\$146,715.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 23. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Six Hundred Sixty-seven Thousand Nine Hundred Eighty-five Dollars (\$3,667,985.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 24. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Hundred Eighty-three Thousand Five Hundred Ninety-one Dollars (\$383,591.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 25. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Reserve Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Forty-five Thousand Dollars (\$45,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 26. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Forty-three Thousand Eight Hundred Sixty-seven Dollars (\$143,867.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for capital improvements to the Capitol buildings.

SECTION 27. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Million Eight Hundred Fourteen Thousand

Six Hundred Fifty-seven Dollars (\$5,814,657.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 28. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Cash-flow Reserve Fund, designated by the Office of State Finance as the "095" Fund, the sum of One Million Two Hundred Sixty Thousand Dollars (\$1,260,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 29. There is hereby appropriated to the State Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Hundred Twenty Thousand Two Hundred Eighty-four Dollars (\$320,284.00) or so much thereof as may be necessary to perform the duties imposed upon the State Ethics Commission by law.

SECTION 30. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Eight Million Four Hundred Ten Thousand Seven Hundred Thirty-two Dollars (\$8,410,732.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 31. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the following amount or so much thereof as may be required for the following purposes:

SECTION 32. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the amount of Ten Million Nine Hundred Thirty-one Thousand One Hundred Seventeen Dollars (\$10,931,117.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the House of Representatives

for the fiscal year ending June 30, 1997, shall be approved by the Speaker of the House of Representatives.

SECTION 33. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and Supplements.

SECTION 34. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the amount of Four Million Six Hundred Ninety Thousand Six Hundred Twelve Dollars (\$4,690,612.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 35. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the amount of Four Hundred Twelve Thousand Four Hundred Forty-four Dollars (\$412,444.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 36. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Hundred Five Thousand Seven Hundred Forty-three Dollars (\$505,743.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 37. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Fifteen Thousand Dollars (\$15,000.00) or so much thereof as may be necessary for legal services when the Attorney General disqualifies himself from legal counsel or representation of the Oklahoma Merit Protection Commission due to conflict of interest. These funds shall be expended exclusively for this purpose and shall not be transferable.

SECTION 38. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Four Million Six Hundred Seventy-one Thousand Six Hundred Ninety-four Dollars (\$4,671,694.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 39. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Five Million One Hundred Forty-six Thousand Sixty-nine Dollars (\$5,146,069.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 40. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Eight Hundred Thirty-seven Thousand Six Hundred Thirty-six Dollars (\$3,837,636.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of

maintaining state buildings operated by the Department of Central Services.

SECTION 41. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Four Thousand Eight Hundred Seventy-five Dollars (\$4,875.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the capitol complex.

SECTION 42. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Nine Hundred Thirty-three Thousand Two Hundred Eighty Dollars (\$933,280.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 43. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Ninety-five Thousand Dollars (\$195,000.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 44. There is hereby appropriated to the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Hundred Twelve Thousand Five Hundred Twenty-five Dollars (\$312,525.00) or so much thereof as may be necessary to perform the duties imposed upon the Secretary of State by law.

SECTION 45. There is hereby appropriated to the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Nineteen Thousand Three Hundred Forty Dollars (\$119,340.00) or so much thereof as may be necessary to implement the Office of Volunteerism.

SECTION 46. There is hereby appropriated to the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of One Hundred Twenty-one Thousand Five Hundred Sixty-five Dollars (\$121,565.00) or so much thereof as may be necessary for the expenses of the Office of Administrative Rules.

SECTION 47. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Nine Thousand Seven Hundred Fifty Dollars (\$9,750.00) or so much thereof as may be necessary for legal publication of ballot titles.

SECTION 48. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent

journals thereof, in accordance with the following amount herein set forth:

For expenses of personal services
(including retirement and insurance costs), including those of members and employees of the Senate, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals and for the renovation and modification of the Senate area \$8,702,026.00

SECTION 49. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Forty-three Million Seventy-five Thousand Three Hundred One Dollars (\$43,075,301.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 50. From the appropriation made in Section 49 of this act, the Oklahoma Tax Commission shall pay an amount not to exceed One Hundred Fifty-eight Thousand Six Hundred Fifty Dollars (\$158,650.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing audits of the Oklahoma Tax Commission and motor license agents as required by law.

SECTION 51. There is hereby appropriated to the Oklahoma Tax Commission for transfer to the Fund for Reimbursement of Counties from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Six Hundred Forty-seven Thousand Five Hundred Forty-three Dollars (\$647,543.00) or so much thereof as may be necessary to reimburse the counties for revenue lost because of the homestead exemption provided for by Section 2890 of Title 68 of the Oklahoma Statutes. No monies shall be disbursed to any county that is not in compliance with the assessment requirements mandated by the Supreme Court of the State of Oklahoma in State ex rel. Poulos v. State Board of Equalization, 646 p.2d 1269, 1273 (Okla. 1982).

SECTION 52. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Four Million Eighty-six Thousand One Hundred Forty-seven Dollars (\$4,086,147.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 114. There is hereby appropriated to the Attorney General's Evidence Fund provided for in Section 19 of Title 74 of the Oklahoma Statutes from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) or so much thereof as may be necessary for expenses relative to any pending case or other matter within the office responsibility of the Attorney General.

SECTION 115. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Forty Thousand Dollars (\$40,000.00) or so much thereof as may be necessary for the required expenses of the Public Employees Relation Board. The monies designated in this section shall be used exclusively for the purpose so stated and shall not be transferable.

SECTION 116. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Twenty-five Million One Hundred Six Thousand Seven Hundred Forty-three Dollars (\$25,106,743.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys and District Attorneys Council by law.

SECTION 117. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of Three Hundred Eighty Thousand Dollars (\$380,000.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to pay witness fees as required by Section 82 of Title 28 of the Oklahoma Statutes.

SECTION 118. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of Twenty-five Thousand Dollars (\$25,000.00) to be transferred to the District Attorneys Evidence Fund.

SECTION 119. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Two Million One Hundred Seventy-four Thousand Three Hundred Sixty-one Dollars (\$2,174,361.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 120. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Seven Million Nine Hundred Forty-seven Thousand

Three Hundred Forty Dollars (\$7,947,340.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 121. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Seventeen Million Seven Hundred Seventeen Thousand Five Hundred Dollars (\$17,717,500.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 122. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the State Judicial Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of One Million One Hundred Twenty Thousand Thirty-seven Dollars (\$1,120,037.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 123. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Three Hundred Fifty-four Thousand Eighty-five Dollars (\$3,354,085.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court or Court of Appeals by law.

SECTION 124. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Four Million Four Hundred Forty-six Thousand One Hundred Thirty Dollars (\$4,446,130.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court or Court of Appeals by law.

SECTION 125. There is hereby appropriated to the Supreme Court Revolving Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 9, Chapter 225, O.S.L. 1994 (20 O.S. Supp. 1994, Section 1310.1).

SECTION 126. There is hereby appropriated to the State Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00) or so much thereof as may be necessary to perform the duties imposed upon the State Supreme Court or Court of Appeals by law.

SECTION 127. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Three Million Three Hundred Sixty-seven Thousand Six Hundred Twenty Dollars (\$3,367,620.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 128. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the Workers' Compensation Administration Fund of the State Treasury for the fiscal year ending June 30, 1995, the sum of Eight Hundred Thousand Five Hundred Thirty-seven Dollars (\$800,537.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 129. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated

from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, the amount of Eight Million One Hundred Twenty-two Thousand Two Hundred Sixty-four Dollars (\$8,122,264.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 130. The appropriations made by this act, but not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 1997 (hereafter FY-97), or may be budgeted for the fiscal year ending June 30, 1998 (hereafter FY-98). Funds budgeted for FY-97 may be encumbered only through June 30, 1997, and must be expended by November 15, 1997. Any funds remaining after November 15, 1997, and not budgeted for FY-98, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-98 may be encumbered only through June 30, 1998. Any funds remaining after November 15, 1998, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-97, and not required to pay obligations for that fiscal year, may be budgeted for FY-98, after the agency has prepared and submitted a budget work program revision removing these funds from the FY-97 budget work program and after such revision has been approved by the Office of State Finance.

SECTION 131. This act shall become effective July 1, 1996.
