A Joint Resolution relating to a designation of the former Clinton-Sherman Air Force Base and other qualified sites as Foreign Trade Zones; recognizing availability of federal law for providing designation; stating importance of former Clinton-Sherman Air Force Base and other qualified sites; stating effect of designation as Foreign Trade Zones; stating source of authority for designation; stating legislative intent with respect to designation; making and declaring designation of area known as Clinton-Sherman Air Force Base and other qualified and approved sites as Foreign Trade Zones; stating intent with respect to requirements of federal law; stating source of authority for designation; and directing filing.

WHEREAS, federal law provides for the ability of states and other government jurisdictions to assist in the process for designating certain areas as Foreign Trade Zones; and

WHEREAS, the provisions of 19 U.S.C., Sections 81a et seq., and federal administrative regulations enacted pursuant to the authority of federal law contain the authorization for the State of Oklahoma to make a designation of an area within its borders as a Foreign Trade Zone; and

WHEREAS, the area formerly known as Clinton-Sherman Air Force Base serves various purposes of intrastate and interstate commerce by providing an efficient method of transportation for commodities and goods essential for the development of a sound economy; and

WHEREAS, other areas of this state have qualities appropriate for designation as a Foreign Trade Zone;

WHEREAS, the designation of the former Clinton-Sherman Air Force Base and any other qualified site in this state as Foreign Trade Zones would further promote the use of these sites by persons and business entities seeking viable locations to conduct profitable and desirable business enterprises; and

WHEREAS, pursuant to Article V, Section 36 of the Oklahoma Constitution, the Legislature of the State of Oklahoma is granted the right to enact laws relating to any rightful subject of legislation; and

WHEREAS, the provisions of the Foreign Trade Zone Act and implementing regulations require a designation as part of the application process to establish a "free trade zone" and the Oklahoma Legislature intends to make the designation as required by federal law.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 45TH OKLAHOMA LEGISLATURE:

THAT the area of the State of Oklahoma commonly referred to as the "Clinton-Sherman Air Force Base", and any site that qualifies and requests designation as a Foreign Trade Zone if approved by the Oklahoma Department of Commerce, located within the border of the State of Oklahoma, is hereby designated by the State of Oklahoma as qualifying for a designation by the appropriate officials of government of the United States as a Foreign Trade Zone.

THAT the Oklahoma Legislature intends that this Joint Resolution fulfill the requirements of 19 C.F.R. Section 400.22(c), 19 C.F.R. Section 400.24(d) (i) and such other requirements of federal law as may exist for the designation of the former Clinton-Sherman Air Force Base and other qualified and approved sites as Foreign Trade Zones.

THAT the State of Oklahoma, pursuant to an Act of Congress dated May 2, 1890, 26 U.S. St. at Large, pp. 81-100, an Act of Congress dated June 16, 1906, 34 U.S. St. at Large, pp. 267-278, and the Constitution of the State of Oklahoma adopted in Convention at Guthrie, Oklahoma, on July 16, 1907, and ratified September 17, 1907, which Constitution became effective upon November 16, 1907, is duly constituted to make the designation contained in this Joint Resolution.

THAT upon enactment of this Joint Resolution copies be filed with the Secretary of State.
