A Concurrent Resolution urging members of the Oklahoma
Congressional Delegation to obtain any and all federal
support that is available to repair damages incurred by the
City of Oklahoma City and the State of Oklahoma in the
bombing of the Alfred P. Murrah Federal Building; and
directing distribution.

WHEREAS, the bombing of the Alfred P. Murrah Federal Building in Oklahoma City has caused untold damages, both human and capital; and

WHEREAS, although it will be impossible to repair the human damage wrought by the senseless terrorist attack, the federal government does possess the ability and resources to repair the capital damages incurred; and

WHEREAS, the bomb damage was so extensive, affecting buildings, streets, sewers and other capital that it would be impossible for the City of Oklahoma City and the State of Oklahoma, with their limited resources, to make the necessary repairs in a timely manner; and

WHEREAS, the Murrah bombing is unprecedented in American history, leaving more public property devastation in its wake than any previous domestic terrorist attack; and

WHEREAS, in time of crisis, the federal government has always answered the call of its local governments and citizens, offering them assistance of all kinds; and

WHEREAS, the federal government should take immediate action to repair the public property damage, supplying unlimited relief and support to the City of Oklahoma City and the State of Oklahoma; and

WHEREAS, the Oklahoma Congressional Delegation should place the highest priority on this request, using its power to obtain such federal assistance and expedite any enabling legislation that is required to bring relief to Oklahoma as quickly as is humanly possible.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 45TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma Legislature hereby urges members of the Oklahoma Congressional Delegation to obtain any and all federal assistance available to repair damages incurred by the City of Oklahoma City and the State of Oklahoma in the Murrah Federal Building bombing.
