A Concurrent Resolution pledging full support and
encouragement to the Board of Directors of Micron
Technology, Incorporated; stating desire to become partners
in the future success of Micron in the State of Oklahoma;
and directing distribution.

WHEREAS, Micron Technology, Inc., has stated its desire to expand outside the State of Idaho; and

WHEREAS, the Micron Technology, Inc., Board of Directors has narrowed its search to the states of Utah, Nebraska, and Oklahoma; and

WHEREAS, Micron Technology, Inc., has stated its desire to construct a new 1.3 billion dollar computer chip manufacturing facility; and

WHEREAS, the State of Oklahoma has expressed its desire to encourage high technology companies to locate within the state; and

WHEREAS, Mr. J.R. Simplot has exhibited vision and courage in leading Micron's battle against foreign competitors, to keep Micron as only one of three U.S. companies to continue the manufacturing of computer memory chips in our nation; and

WHEREAS, the Oklahoma Legislature wishes to express to Mr. Steve Appleton, Chairman of the Board of Directors of Micron Technology, Inc., its strongest desires to have their company located in the State of Oklahoma; and

WHEREAS, Oklahoma's Quality Jobs Program offers tax rebates for job creation; and

WHEREAS, Oklahoma has created a distance learning fiber optic network by which a plant site can be directly linked to Oklahoma State University in Stillwater, the University of Oklahoma in Norman and with community colleges and vocational-technical education centers; and

WHEREAS, Oklahoma's vocational and technical educational system is ranked among the top three in the United States; and

WHEREAS, Oklahoma has an abundance of electrical energy and natural gas; at least four 600-acre sites on which to construct the Micron plant; an abundance of ground water; quality education systems that ensure a supply of engineers and continuing education opportunities for employees; an outstanding highway and road system which offers fast transportation throughout the metropolitan area; a central location which will reduce shipping costs; and a large, quality, productive workforce with competitive wage rates; and

WHEREAS, Oklahoma City is the largest city in the United States to achieve attainment status in both water and air quality; and

WHEREAS, the University of Oklahoma and Oklahoma State University both boast nationally recognized engineering schools with Oklahoma State University operating a technical branch in Oklahoma City, which is linked to its Stillwater campus by fiber optics.
