AS INTRODUCED

An Act relating to schools; repealing Section 15, Chapter 308, O.S.L. 1992, which relates to repeal of certain teacher certification and licensure provisions; repealing 70 O.S. 1991, Sections 6-123.1, 6-124.1, 6-125 and 6-126, which relate to professional standards board; repealing 70 O.S. 1991, Section 6-150, which relates to in-service teacher education programs; repealing 70 O.S. 1991, Section 6-151, which relates to qualification of teachers; repealing 70 O.S. 1991, Section 6-152, which relates to definitions; repealing 70 O.S. 1991, Section 6-153, which relates to screening of college applicant; repealing 70 O.S. 1991, Section 6-154, which relates to licensure and certification; repealing 70 O.S. 1991, Section 6-155, as amended by Section 10, Chapter 324, O.S.L. 1992 (70 O.S. Supp. 1994, Section 6-155), which relates to the entry-year assistance program; repealing 70 O.S. 1991, Sections 6-157, 6-158, as amended by Section 1, Chapter 388, O.S.L. 1992, and 6-158.1 (70 O.S. Supp. 1994, Section 6-158), which relate to staff development; repealing 70 O.S. 1991, Section 6-162, which relates to persons subject to licensure and certification; repealing

70 O.S. 1991, Section 6-163, which relates to cooperative programs; repealing 70 O.S. 1991, Section 6-164, which relates to rules and regulations and curriculum examinations; repealing 70 O.S. 1991, Section 6-165, which relates to emergency certification; repealing 70 O.S. 1991, Section 6-170, which relates to public filing of certification; repealing 70 O.S. 1991, Section 6-156, which relates to curriculum examinations; providing effective dates; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER Section 15, Chapter 308, O.S.L. 1992, is hereby repealed.

SECTION 2. REPEALER 70 O.S. 1991, Sections 6-123.1, 6-124.1, 6-125, 6-126, 6-150, 6-151, 6-152, 6-153, 6-154, 6-155, as amended by Section 10, Chapter 324, O.S.L. 1992, 6-157, 6-158, as amended by Section 1, Chapter 388, O.S.L. 1992, 6-158.1, 6-162, 6-163, 6-164, 6-165 and 6-170 (70 O.S. Supp. 1994, Sections 6-155 and 6-158), are hereby repealed.

SECTION 3. REPEALER 70 O.S. 1991, Section 6-156, is hereby repealed.

SECTION 4. Section 1 of this act shall become effective August 31, 1995.

SECTION 5. Section 2 of this act shall become effective September 1, 1995.

SECTION 6. Section 3 of this act shall become effective September 1, 1996.

SECTION 7. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
