AS INTRODUCED

A Concurrent Resolution mourning the loss of a former member of the Oklahoma House of Representatives, the Honorable Leroy O. Fields; expressing heartfelt condolences and extending deepest sympathy to the family members of Leroy O. Fields; and directing distribution.

WHEREAS, Leroy O. Fields passed away at the age of 87 on Sunday, March 5, 1995, at the Baptist Regional Medical Center in Miami, Oklahoma; and

WHEREAS, Leroy O. Fields was born to Thomas and Alta Hutchison Fields on November 18, 1908, in Delaware County and was a life-long resident of that county; and

WHEREAS, Leroy O. Fields married Mable Cates in 1933 at Vinita, Oklahoma; and

WHEREAS, Leroy and Mable Fields together raised two adoring children, Rick and Mary Lou; and

WHEREAS, Leroy O. Fields was a member of the Oklahoma House of Representatives during the Twentieth Legislative Session in 1945, a businessman in Jay, an educator teaching at the Consistory School for the Masonic Lodge, and one of the first volunteer firemen in the great State of Oklahoma; and

WHEREAS, Leroy O. Fields was also a member of the First Baptist Church in Jay, the Tulsa Shrine and a charter member of the Jay Masonic Lodge; and

WHEREAS, Leroy O. Fields was eulogized at the First Baptist Church in Jay and laid to rest at the Mount Hermon Cemetery on Wednesday, March 8, 1995; and

WHEREAS, Leroy O. Fields will live on in the hearts of those who loved him.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 45TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:
