AS INTRODUCED

A Resolution commending and congratulating the Honorable Larry Warden, chief clerk/administrator of the Oklahoma House of Representatives, for his election as president of the American Society of Legislative Clerks and Secretaries; and directing distribution.

WHEREAS, the Honorable Larry Warden has been chief clerk/administrator of the Oklahoma House of Representatives since 1983; and

WHEREAS, Larry Warden has been a member of the House staff for more than a quarter century, serving in numerous important positions; and

WHEREAS, Larry Warden is a tireless public servant who has dedicated his career to the institution of the House of Representatives, its members, and their constituents; and

WHEREAS, Larry Warden's love for and dedication to the institution of the state legislature led to his involvement in the American Society of Legislative Clerks and Secretaries; and

WHEREAS, the American Society of Legislative Clerks and Secretaries is an organization affiliated with the National Conference of State Legislatures comprised of the duly elected or appointed legislative clerks and secretaries of the fifty states and the insular possessions and territories of the United States of America; and

WHEREAS, the American Society of Legislative Clerks and Secretaries is an organization dedicated to improving the administrative and parliamentary effectiveness of state legislatures and developing better procedures for enhancing the lawmaking function; and

WHEREAS, in the past several years, Larry Warden has served the American Society of Legislative Clerks and Secretaries in an impressive list of leadership positions; and

WHEREAS, in October 1995, the members of the American Society of Legislative Clerks and Secretaries gathered in Oklahoma City for their annual meeting and professional development seminar; and

WHEREAS, on Monday, October 2, 1995, upon the recommendation of its Nominating Committee, the American Society of Legislative Clerks and Secretaries unanimously elected the Honorable Larry Warden to be its president; and

WHEREAS, Larry Warden's election was history-making as he is the first president of the American Society of Legislative Clerks and Secretaries to ascend to that office on the soil of his home state; and

WHEREAS, the Oklahoma House of Representatives wishes to honor its own chief clerk/administrator, the Honorable Larry Warden, for his outstanding service to the House of Representatives, the people of Oklahoma, the American Society of Legislative Clerks and Secretaries, and to the institution of the state legislature across this nation.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 45TH OKLAHOMA LEGISLATURE:
