College, Tulsa Junior College, the Enid Higher Education Program, the Ardmore Higher Education Program, higher education facilities at Muskogee, and the Idabel (McCurtain County) Higher Education Program; providing for reappropriation of certain funds to the State Department of Vocational and Technical Education, the Board of Trustees of the School of Science and Mathematics, the Office of State Finance, the Oklahoma Water Resources Board, the Oklahoma Tourism and Recreation Department, the Oklahoma Historical Society, the Oklahoma Department of Libraries, the Department of Corrections, the Military Department of the State of Oklahoma, the State Department of Health, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the Department of Central Services, the Legislative Service Bureau, the Department of Mental Health, and the Department of Human Services; expressing intent of the Legislature; prohibiting use of reappropriations for certain purposes; making certain reappropriations contingent upon a local match of certain funds; making appropriations nonfiscal; stating lapse period; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
