AS INTRODUCED

An Act relating to law enforcement entities;

specifying that all funds of the Alcoholic Beverage  
Laws Enforcement Commission be included in certain  
budget categories; providing for the duties and  
compensation of employees; limiting salary of the  
Director; providing that certain positions shall be  
unclassified positions; providing budgetary  
limitations; specifying that all funds of the  
Council on Law Enforcement Education and Training  
be included in certain budget categories; providing  
for the duties and compensation of employees;  
limiting salary of the Director; providing  
budgetary limitations; specifying that all funds of  
the Oklahoma State Bureau of Investigation be  
included in certain budget categories; providing  
for the duties and compensation of employees;  
limiting salary of the Director; providing  
budgetary limitations; specifying that all funds of  
the Oklahoma State Bureau of Narcotics and  
Dangerous Drugs Control be included in certain  
budget categories; providing for the duties and  
compensation of employees; limiting salary of the  
Director; providing budgetary limitations;  
specifying that all funds of the Department of

Public Safety be included in certain budget categories; providing for the duties and compensation of employees; providing budgetary limitations; providing exceptions to the budgetary limitations; specifying that all funds of the Board of Medicolegal Investigations be included in certain budget categories; providing for the duties and compensation of employees; limiting the salary of the Chief Medical Examiner; providing budgetary limitations; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

ALCOHOLIC BEVERAGE LAWS ENFORCEMENT COMMISSION

SECTION 1. For the fiscal year ending June 30, 1997, the Alcoholic Beverage Laws Enforcement Commission shall budget all funds in the following categories:

SECTION 2. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Alcoholic Beverage Laws Enforcement Commission by law shall be set by the Director. The salary of the Director shall not exceed Fifty-five Thousand Four Hundred Five Dollars (\$55,405.00) per annum, payable monthly for the fiscal year ending June 30, 1997.

Three (3) Administrative Service Assistants shall be unclassified positions. The Alcoholic Beverage Laws Enforcement Commission for the fiscal year ending June 30, 1997, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

The Oklahoma State Bureau of Investigation for the fiscal year ending June 30, 1997, shall be subject to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:
