AS INTRODUCED

A Concurrent Resolution directing the State Auditor and Inspector to perform certain audits; directing the Department of Central Services to perform certain inventories; requiring filing of certain audits and inventories; directing the Contingency Review Board to disapprove any lease agreement regarding lease and operations of University Hospitals until certain audits and inventories are performed; and directing distribution.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

WHEREAS, Section 3225 of Title 63 of the Oklahoma Statutes provides that any proposed agreement regarding the lease and operations of the University Hospitals must be submitted to the Contingency Review Board for review, and should the Contingency Review Board disapprove the proposed agreement, the agreement shall not be executed, and

WHEREAS, Section 213.2 of Title 74 of the Oklahoma Statutes provides that the State Auditor and Inspector shall conduct an audit of any state governmental entity if directed to do so in a concurrent resolution of the Legislature, and

WHEREAS, Section 110.1 of Title 74 of the Oklahoma Statutes provides that the Department of Central Services is responsible for maintaining a current inventory of equipment owned by any state governmental entity.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2nd SESSION OF THE 45th OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the State Auditor and Inspector shall examine and report on all books and financial accounts of the University Hospitals Authority and the University Hospitals and file a copy of the audits with the members of the Contingency Review Board.

THAT the Department of Central Services shall complete an inventory of all equipment owned by the University Hospitals Authority and the University Hospitals and file a copy of the inventory with the members of the Contingency Review Board.

THAT the Contingency Review Board shall disapprove any agreement regarding the lease and operations of the University Hospitals until:

1. The State Auditor and Inspector examines and reports upon the books and financial accounts of the University Hospitals Authority and the University Hospitals and files copies of the audits as directed in this resolution; and

2. The Department of Central Services completes a current inventory of equipment owned by the University Hospitals Authority and the University Hospitals and files copies of the inventory as directed in this resolution.

THAT the costs of the audit by the State Auditor and Inspector shall be borne by the University Hospitals Authority in accordance with the Oklahoma Statutes.

THAT copies of this resolution be distributed to the Governor, the Director of the Office of State Finance, the University Hospitals Authority, the State Auditor and Inspector, and the Department of Central Services.
