CONFERENCE COMMITTEE SUBSTITUTE

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Department of Libraries, the Physician Manpower Training Commission, the Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Vocational and Technical Education, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund, the Department of Central Services, the Oklahoma Capitol Improvement Authority, the Department of Civil Emergency Management, the State Election Board, the Office of State Finance, the Office of the Governor, the State Emergency Fund, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Commission on Children and Youth, the Office of Handicapped Concerns, the State Department of Health, the Human Rights Commission, the Indian Affairs Commission, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the Oklahoma Department of Veterans Affairs, the Oklahoma Health Care Authority, the Department of Human Services, the Welfare Reform Initiative Fund, the Department of Rehabilitation Services, the University Hospitals Authority, the Office of Juvenile Affairs, the State Department of Agriculture, the Oklahoma Conservation Commission, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Liquefied Petroleum Gas Board, the Department of Mines, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the State Banking Department, the Oklahoma Department of Commerce, the Department of Consumer Credit, the Corporation

Commission, the Department of Environmental Quality, the Oklahoma Horse Racing Commission, the State Insurance Department, the Oklahoma Department of Labor, the Oklahoma Securities Commission, the Office of the Attorney General, the Court of Criminal Appeals, the State Supreme Court, the State Ethics Commission, the Oklahoma Indigent Defense System, the Workers' Compensation Court, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Department of Transportation and the Oklahoma State Employees Deferred Savings Incentive Plan Fund; stating sums of the appropriations; stating purposes and restrictions; requiring and prohibiting certain budgetary procedures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million Four Hundred Ninety-five Thousand Two Hundred Sixty-seven Dollars (\$3,495,267.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Billion One Hundred Sixty-five Million Four Hundred Thousand Five Hundred Twenty-five Dollars (\$1,165,400,525.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Three Hundred Twenty-two Million Six Hundred Seventy-one Thousand Two Hundred Ninety-nine Dollars (\$322,671,299.00) or so much

thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 1997, the sum of Nine Hundred Forty-eight Thousand Nine Dollars (\$948,009.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Eighty-nine Million Nine Hundred Seventy-four Thousand Two Hundred Thirty-five Dollars (\$89,974,235.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Three Million Seven Hundred Thousand Dollars (\$3,700,000.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Nineteen Million One Hundred Ninety-six Thousand Four Hundred Forty-eight Dollars (\$19,196,448.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Two Hundred Thirty Thousand Dollars (\$230,000.00) or so much thereof as may be necessary for the duties imposed upon the Office of Accountability by law.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Eighteen Million One Hundred

Twenty-three Thousand Seven Hundred Thirty-eight Dollars (\$18,123,738.00) or so much thereof as may be necessary for Administrative and Support Functions of the State Department of Education.

SECTION 10. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million Two Hundred Eighty-three Thousand Six Hundred Eighty-one Dollars (\$3,283,681.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 11. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Six Hundred Fifty Million Eight Hundred Thirty-five Thousand One Hundred Seventy-four Dollars (\$650,835,174.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 12. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million Nine Hundred Seventeen Thousand Seven Hundred Eighty-seven Dollars (\$3,917,787.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 13. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirty-eight Million Five Hundred Forty-six Thousand Four

Hundred Thirty Dollars (\$38,546,430.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 14. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million Eight Hundred Forty-seven Thousand One Hundred Five Dollars (\$3,847,105.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 15. There is hereby appropriated to the Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Million Nine Hundred Eighty-two Thousand One Hundred Ninety-three Dollars (\$5,982,193.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Libraries by law.

SECTION 16. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Million Ninety Thousand Two Hundred Forty-five Dollars (\$5,090,245.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 17. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 18. There is hereby appropriated to the Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Thirty-eight Thousand Two Hundred Eighty-three Dollars (\$138,283.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 19. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Four Million Three Hundred Thirty-nine Thousand Fifty-three Dollars (\$4,339,053.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 20. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Nine Million Fifty-nine Thousand Two Hundred Seventy-two Dollars (\$9,059,272.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 21. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Six Hundred Twenty-four Thousand Five Hundred Ten Dollars (\$624,510.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 22. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Nine Hundred Five Thousand Seven Hundred Thirty-seven Dollars (\$905,737.00) or so much thereof as may be necessary to

perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 23. There is hereby appropriated to the State Board of Vocational and Technical Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Four Million Eight Hundred Fifty Thousand Four Hundred Seventeen Dollars (\$104,850,417.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Vocational and Technical Education by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT

SECTION 24. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Four Million Two Hundred Ninety-three Thousand Nine Hundred Sixty-eight Dollars (\$4,293,968.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 25. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Hundred Eighty-three Thousand Five Hundred Ninety-one Dollars (\$383,591.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 26. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Forty-five Thousand Dollars (\$45,000.00) or so much thereof as may be necessary to provide uniform computer systems development, including computer software for county government, in accordance

with the State Auditor and Inspector's duties to prescribe accounting procedures and to provide technical assistance to county government. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 27. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Twelve Million Five Hundred Thousand Dollars (\$12,500,000.00) or so much thereof as may be necessary to implement the provisions of Section 2004 of Title 62 of the Oklahoma Statutes.

SECTION 28. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Seven Million One Hundred Twelve Thousand Six Hundred Twenty-two Dollars (\$7,112,622.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 29. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Three Million Eight Hundred Sixty-seven Thousand Six Hundred Thirty-six Dollars (\$3,867,636.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 30. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Four Thousand Eight Hundred Seventy-five Dollars (\$4,875.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 31. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Million One Hundred Ninety-four Thousand One Hundred Three Dollars (\$1,194,103.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 32. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Ninety-five Thousand Dollars (\$195,000.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 33. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Ten Million Three Hundred Fifty-eight Thousand Three Hundred Twenty Dollars (\$10,358,320.00) for transfer to the Capital Improvement Revolving Fund.

SECTION 34. There is hereby appropriated to the Oklahoma Capitol Improvement Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Forty-three Thousand Eight Hundred Sixty-seven Dollars (\$143,867.00) or so much thereof as may be necessary for the purpose of retiring bonds issued by the Authority for capital improvements to the Capitol buildings.

SECTION 35. There is hereby appropriated to the Department of Civil Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Hundred Seventy-eight Thousand Thirty-seven Dollars (\$578,037.00) or so

much thereof as may be necessary to perform the duties imposed upon the Department of Civil Emergency Management by law.

SECTION 36. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Million Six Hundred Seventy-six Thousand Sixty-seven Dollars (\$5,676,067.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 37. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Hundred Thousand Dollars (\$200,000.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 38. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million Two Hundred Sixty Thousand Dollars (\$1,260,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 39. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Eight Million Six Hundred Sixty-eight Thousand Three Hundred Seventy-nine Dollars (\$8,668,379.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 40. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the following amount or so much thereof as may be required for the following purposes:

SECTION 41. There is hereby appropriated to the State Emergency Fund created pursuant to Section 139.42 of Title 62 of the Oklahoma Statutes from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million Dollars (\$1,000,000.00) or so much thereof as may be necessary for state emergencies.

SECTION 42. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Sixteen Million Nine Hundred Twenty-two Thousand Seven Hundred Thirteen Dollars (\$16,922,713.00) or so much thereof as may be necessary to pay the salaries, per diem, and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 1999, shall be approved by the Speaker of the House of Representatives.

SECTION 43. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Hundred

Fifty Thousand Dollars (\$550,000.00) or so much thereof as may be necessary for the purchase of Oklahoma Statutes, Session Laws, and Supplements.

SECTION 44. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Million Four Hundred Ninety-two Thousand Two Hundred Twenty Dollars (\$1,492,220.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 45. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Four Hundred Thirty-five Thousand Nine Hundred Ten Dollars (\$435,910.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 46. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Hundred Thirty-nine Thousand Nine Hundred Sixty-seven Dollars (\$539,967.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 47. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Five Million Nine Hundred Twenty-eight Thousand Seven Hundred Seventy-three Dollars (\$5,928,773.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 48. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal

year ending June 30, 1999, the sum of Five Million Two Hundred Fifty Thousand Four Hundred Thirty-two Dollars (\$5,250,432.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 49. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Two Hundred Forty-six Thousand Four Hundred Fifty-nine Dollars (\$246,459.00) or so much thereof as may be necessary to perform the duties imposed upon the Secretary of State by law.

SECTION 50. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of One Hundred Thirty Thousand Two Hundred Eight Dollars (\$130,208.00) or so much thereof as may be necessary for the expenses of the Office of Administrative Rules.

SECTION 51. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Nine Thousand Seven Hundred Fifty Dollars (\$9,750.00) or so much thereof as may be necessary for legal publication of ballot titles.

SECTION 52. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personal services

(including retirement and insurance

costs), including those of members and employees of the Senate, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals and for the renovation and modification of the Senate area \$12,316,897.00

SECTION 53. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Forty-five Million Three Hundred Eighty-one Thousand Eight Hundred Ninety-five Dollars (\$45,381,895.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 54. From the appropriation made in Section 53 of this act, the Oklahoma Tax Commission shall pay an amount not to exceed One Hundred Fifty-eight Thousand Six Hundred Fifty Dollars (\$158,650.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing audits of the Oklahoma Tax Commission and motor license agents as required by law.

Said appropriation shall be transferred to the State Highway Construction and Maintenance Fund and shall be expended in the same manner and for the same purposes as provided by law for other monies accruing to the credit of the State Highway Construction and Maintenance Fund.

SECTION 134. There is hereby appropriated to the Oklahoma State Employees Deferred Savings Incentive Plan Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1999, the sum of Two Million Dollars (\$2,000,000.00) or so much thereof as may be necessary to provide contributions to qualified participants pursuant to Section 1707 of Title 74 of the Oklahoma Statutes.

SECTION 135. The appropriations made by this act, but not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 1999 (hereafter FY-99), or may be budgeted for the fiscal year ending June 30, 2000 (hereafter FY-00). Funds budgeted for FY-99 may be encumbered only through June 30, 1999, and must be expended by November 15, 1999. Any funds remaining after November 15, 1999, and not budgeted for FY-00, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-00 may be encumbered only through June 30, 2000. Any funds remaining after November 15, 2000, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-99, and not required to pay obligations for that fiscal year, Req. No. 10345Page 31

may be budgeted for FY-00, after the agency has prepared and submitted a budget work program revision removing these funds from the FY-99 budget work program and after such revision has been approved by the Office of State Finance.

SECTION 136. This act shall become effective July 1, 1998.
