A Concurrent Resolution relating to rules of the Board of Embalmers and Funeral Directors; waiving the thirty-legislative-day review period for proposed amendments to permanent rules OAC 235:10-1-2, OAC 235:10-3-1, OAC 235:10-3-2, OAC 235:10-3-3, OAC 235:10-3-4, OAC 235:10-3-5, OAC 235:10-5-1, OAC 235:10-7-1, OAC 235:10-7-2, OAC 235:10-9-9, OAC 235:10-9-11, OAC 235:10-11-1, OAC 235:10-15-4 and proposed revocations of permanent rules OAC 235:10-3-4.1 and OAC 235:10-15-2 regarding funeral services licensing; and directing distribution.

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, the Legislature may waive the thirty-legislative-day review period for any rule which has been transmitted for legislative review; and

WHEREAS, on April 15, 1997 the Board of Embalmers and Funeral Directors submitted proposed amendments to permanent rules OAC 235:10-1-2, OAC 235:10-3-1, OAC 235:10-3-2, OAC 235:10-3-3, OAC 235:10-3-4, OAC 235:10-3-5, OAC 235:10-5-1, OAC 235:10-7-1, OAC 235:10-7-2, OAC 235:10-9-9, OAC 235:10-9-11, OAC 235:10-11-1, OAC 235:10-15-4 and proposed revocations of permanent rules OAC 235:10-3-4.1 and OAC 235:10-15-2 relating to funeral services licensing regarding general provisions; qualifications and requirements for licensure; licensing fees; license renewal, revocation, and suspension; procedures for the disposition of complaints; minimum

standards of performance; and advertising to the Legislature for its review; and

WHEREAS, the Legislature recognizes the substantive value and importance of such rules.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 46TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the Legislature hereby waives the thirty-legislative-day review period of the proposed amendments to permanent rules OAC 235:10-1-2, OAC 235:10-3-1, OAC 235:10-3-2, OAC 235:10-3-3, OAC 235:10-3-4, OAC 235:10-3-5, OAC 235:10-5-1, OAC 235:10-7-1, OAC 235:10-7-2, OAC 235:10-9-9, OAC 235:10-9-11, OAC 235:10-11-1, OAC 235:10-15-4 and proposed revocations of permanent rules OAC 235:10-3-4.1 and OAC 235:10-15-2 relating to funeral services licensing of the Board of Embalmers and Funeral Directors.
