WHEREAS, not only has Shannon Miller excelled in the world of gymnastics with seven Olympic medals, two world championships and

two national championships, she has excelled as an ambassador for this state; and

WHEREAS, Shannon Miller is a truly remarkable person who has won the hearts of the world for both her athletic talents and her work for worthwhile projects, such as the Children's Miracle Network, "Feed the Children" and the March of Dimes; and

WHEREAS, Shannon Miller serves as a positive role model for the youth of this nation and shows Oklahoma to the world in a positive manner; and

WHEREAS, Shannon Miller's character, achievements and involvement in projects of importance to this state merit recognition.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 46TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the portion of Interstate Highway 35, extending from Memorial Road to Danforth Road, in Oklahoma County, shall be designated the "Shannon Miller Parkway" in honor of Oklahoma's premier gymnast, Shannon Miller, whose many accomplishments are a source of great pride for the people of this state.

THAT the Oklahoma Department of Transportation shall cause suitable permanent markers to be placed upon the highway bearing the name Shannon Miller Parkway.

THAT copies of this resolution be dispatched to Shannon Miller and to the Secretary of Transportation.
