A Concurrent Resolution relating to rules of the Oklahoma Tax Commission; waiving the thirty-legislative-day review period for proposed amendments to permanent rules OAC 710:45-1-3, OAC 710:45-3-11, OAC 710:45-5-3, OAC 710:45-5-5, OAC 710:45-9-21, OAC 710:45-9-32.1, OAC 710:45-9-41, OAC 710:45-9-51, OAC 710:45-9-60, OAC 710:45-9-70, OAC 710:45-9-71, OAC 710:45-9-82 and proposed revocation of permanent rule OAC 710:45-9-61, which relate to gross production, petroleum excise and conservation excise taxes; and directing distribution.

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, the Legislature may waive the thirty-legislative-day review period for any rule which has been transmitted for legislative review; and

WHEREAS, on March 13, 1998, the Oklahoma Tax Commission submitted to the Legislature for its review proposed amendments to permanent rules OAC 710:45-1-3, OAC 710:45-3-11, OAC 710:45-5-3, OAC 710:45-5-5, OAC 710:45-9-21, OAC 710:45-9-32.1, OAC 710:45-9-41, OAC 710:45-9-51, OAC 710:45-9-60, OAC 710:45-9-70, OAC 710:45-9-71, OAC 710:45-9-82 and proposed revocation of permanent rule OAC 710:45-9-61, relating to gross production, petroleum excise and conservation excise taxes, regarding general provisions; payment, remittance, refunds; required returns and reports; and exemptions and exclusions; and

WHEREAS, the Legislature recognizes the substantive value and importance of such proposed revocation and amendments to the permanent rules.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 46TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the Legislature hereby waives the thirty-legislative-day review period of the proposed amendments to permanent rules OAC 710:45-1-3, OAC 710:45-3-11, OAC 710:45-5-3, OAC 710:45-5-5, OAC 710:45-9-21, OAC 710:45-9-32.1, OAC 710:45-9-41, OAC 710:45-9-51, OAC 710:45-9-60, OAC 710:45-9-70, OAC 710:45-9-71, OAC 710:45-9-82 and proposed revocation of permanent rule OAC 710:45-9-61.

THAT copies of this resolution shall be distributed to the Governor, the Tax Commissioners and the Editor of "The Oklahoma Register".
