An Act relating to the reappropriation of public funds; making reappropriations to the Oklahoma State Regents for Higher Education for the University of Oklahoma, the University of Oklahoma Health Sciences Center, Oklahoma State University, Oklahoma State University Technical Branch - Okmulgee, Oklahoma State University - Veterinary Medicine, Oklahoma State University Technical Branch - Oklahoma City, Oklahoma State University - College of Osteopathic Medicine, the University of Central Oklahoma, East Central University, Northeastern State University, Northwestern Oklahoma State University, Southeastern Oklahoma State University, Southwestern Oklahoma State University, Cameron University, Langston University, Oklahoma Panhandle State University, the University of Science and Arts of Oklahoma, the University Center at Tulsa, Carl Albert State College, Connors State College, Eastern Oklahoma State College, Murray State College, Northeastern Oklahoma A&M College, Northern Oklahoma College, Oklahoma City Community College, Redlands Community College, Rogers State College, Rose State College, Seminole Junior College, Tulsa Junior College, Western Oklahoma State College, the Enid Higher Education Program, the Ardmore Higher Education Program, higher education facilities at Muskogee, and the Idabel (McCurtain County) Higher Education Program; making reappropriations to the State Department of Vocational and Technical Education, the Board of Trustees of the School of Science and Mathematics, the Oklahoma Water Resources Board, the Oklahoma Tourism and Recreation Department, the Oklahoma Historical Society, the Oklahoma Department of Libraries, the Department of Corrections, the Military Department of the State of Oklahoma, the State Department of Health, the Oklahoma Department of Veterans Affairs, the State Department of Agriculture, the Department of Central Services, the Legislative Service Bureau, the Office of State Finance, the Department of Mental Health and the Department of Human Services; making reappropriations nonfiscal; stating lapse period; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REAPPROPRIATION The amount of Twenty Million Three Hundred Sixteen Thousand Six Hundred Two Dollars (\$20,316,602.00) originally appropriated to the Oklahoma State Regents for Higher Education for the University of Oklahoma by Section 3, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 1, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for the University of Oklahoma in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 2. REAPPROPRIATION The amount of Twelve Million Six Hundred Sixty-one Thousand Eighty Dollars (\$12,661,080.00) originally appropriated to the Oklahoma State Regents for Higher Education for the University of Oklahoma - Health Sciences Center by Section 5, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 2, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for the University of Oklahoma - Health Sciences Center in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 3. REAPPROPRIATION The amount of Nine Million Eight Hundred Twenty-eight Thousand Dollars (\$9,828,000.00) originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University by Section 7, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 3, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 4. REAPPROPRIATION The amount of Four Million Dollars (\$4,000,000.00) originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University by Section 8, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for renovation of the Agriculture Experiment Station, as reappropriated by Section 4, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University in the original amount and for the original purpose, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 5. REAPPROPRIATION The amount of Two Million Two Hundred Twenty-one Thousand Six Hundred Two Dollars (\$2,221,602.00)

originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University - Technical Branch, Okmulgee by Section 9, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 5, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University - Technical Branch, Okmulgee in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 6. REAPPROPRIATION The amount of Five Million Seventy-five Thousand Dollars (\$5,075,000.00) originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University - Veterinary Medicine by Section 11, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 6, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to Oklahoma State Regents for Higher Education for Oklahoma State University - Veterinary Medicine in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 7. REAPPROPRIATION The amount of Three Million Eight Hundred Sixty-eight Thousand Dollars (3,868,000.00) originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University - Technical Branch, Oklahoma City by Section 13, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 7, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University - Technical Branch, Oklahoma City in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 8. REAPPROPRIATION The amount of Three Million Seven Hundred Fifty Thousand Four Hundred Dollars (\$3,750,400.00) originally appropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University of Osteopathic Medicine by Section 14, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 8, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for Oklahoma State University of Osteopathic Medicine in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 9. REAPPROPRIATION The amount of Seven Million Seven Hundred Sixty-five Thousand One Hundred Six Dollars

(\$7,765,106.00) originally appropriated to the Oklahoma State Regents for Higher Education for the University of Central Oklahoma by Section 16, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (A) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 9, Chapter 275, O.S.L. 1995, is hereby continued and reappropriated to the Oklahoma State Regents for Higher Education for the University of Central Oklahoma in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 10. SECTION 11. SECTION 14. SECTION 16. SECTION 84. REAPPROPRIATION The amount of Four Hundred Thousand Dollars (\$400,000.00) originally appropriated to the Department of Mental Health by Section 120, Chapter 189, O.S.L. 1993, from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund (B) in the State Treasury for the construction, furnishing and equipping of new buildings, for equipping, remodeling, modernizing and repairing existing buildings, and for other capital expenditures, as reappropriated by Section 84, Chapter 275, O.S.L. 1995, for the Center for Pregnant Women with Substance Abuse located in Tulsa, Oklahoma, is hereby continued and reappropriated to the Department of Mental Health in the original amount and for the original purposes, as adjusted by transfer, less the amounts that have been expended as of the effective date of this act.

SECTION 85. The appropriations made by this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.

SECTION 86. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
