WHEREAS, this year, the chairpersons of BALTO, Marilyn Klopp and Kelli Herlihy, did an extraordinary job of leading the student body in this fund-raiser to benefit Stephanie; and

WHEREAS, the student body participated in many successful fund-raising events with the main goal of making a little four-year-old girl's life, and the lives of her parents and brother, happier and more optimistic for the future.
