WHEREAS, the fund-raising event was held this year to aid sophomore student, Matt Jones. Matt was involved in an automobile accident which left him hospitalized for nearly three months and left his family faced with enormous medical bills; and

WHEREAS, with great enthusiasm, the student body raised over \$41,000.00 for Matt; and

WHEREAS, Matt is a newcomer to the school and because he and his family had just moved to Edmond, they did not have a local, close-knit support network until the students chose Matt to be the recipient of the financial and emotional support of "Double Wolf Dare Week"; and

WHEREAS, the chairman of Double Wolf Dare Week, Yale Scott, was very effective in leading the fund week to benefit Matt and his family, and

WHEREAS, the school with its "Double Wolf Dare Week" had events planned including a basketball tournament, skating party, students working as carhops at Sonic Drive-Ins with tips going into the fund, students participating in silly stunts, a Price is Right game show, and a Battle of the Bands; and

WHEREAS, the high school even received donations collected by elementary and middle school students in Edmond who are interested in helping Matt and his family; and

WHEREAS, Oklahoma is proud of the student body of Edmond Santa Fe High School and of the elementary and middle schools who have shown great compassion and support for one of their own, Matt Jones.
