A Concurrent Resolution honoring Olympic Gold Medal Winner  
Shannon Miller; praising her activities as a worthy role  
model for all Oklahomans; and directing distribution.

WHEREAS, Shannon Lee Miller was born in Rolla, Missouri, on March 10, 1977, weighing five pounds and seven ounces. The Miller family moved to Edmond, Oklahoma, when Shannon was five months old; and

WHEREAS, Shannon Miller, a seven-time Olympic medalist, two-time all-around world champion, two-time national champion, has competed at a national level since she was 11 years of age, and was in her first Olympics in Barcelona, Spain, at 15 years of age; and

WHEREAS, Shannon Miller, at last year's Olympics in Atlanta, Georgia, after leading the team to a gold medal, then suffering disappointment in the all-around and vault competitions, rebounded and won an individual Olympic gold medal on the beam for the United States during the summer games to become the most decorated woman gymnast in American history; and

WHEREAS, Shannon Miller had a goal and worked for it steadfastly despite injuries and obstacles. Her secret is one of hard work, discipline, dedication and commitment; and

WHEREAS, Shannon Miller graduated from the Edmond public school system with nearly an "A" average and is attending the University of Oklahoma; and

WHEREAS, Shannon Miller has set an example of hard work, discipline, dedication and commitment that exemplifies a role model all Oklahomans can follow.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION OF THE 46TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Oklahoma State Legislature honors Olympic Gold Medal Winner Shannon Miller.

THAT the Oklahoma State Legislature praises her as a worthy Oklahoma role model.

THAT copies of this resolution be distributed to Shannon Miller; her coaches, Steve Nunno and Peggy Liddick; and her parents, Claudia and Dr. Ronald Miller.
