An Act relating to State Finance; directing certain transfers; specifying date of transfer; repealing Section 7 of Enrolled House Bill No. 3010 of the 2nd Session of the 46th Oklahoma Legislature, which relates to transfer of certain funds; stating purpose; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. TRANSFER The Director of State Finance, on July 1, 1998, shall transfer the sum of Fifty Thousand Dollars (\$50,000.00) of the amount of Five Million One Hundred Ninety-nine Thousand Four Hundred Twelve Dollars (\$5,199,412.00) originally appropriated to the Office of Personnel Management by Section 38, Chapter 60, O.S.L. 1997, from any monies in the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, not otherwise appropriated, for duties imposed upon the Office of Personnel Management by law, to the Special Cash Fund of the State Treasury.

SECTION 2. TRANSFER The Director of State Finance, on July 1, 1998, shall transfer the sum of Eighty-six Thousand Nine Hundred Ninety-eight Dollars (\$86,998.00) of the amount of Three Million One Hundred Forty-two Thousand Nine Hundred Ninety-eight Dollars (\$3,142,998.00) originally appropriated to the Office of the State Treasurer by Section 52, Chapter 9, O.S.L. 1996, from any monies in the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, not otherwise appropriated, for duties imposed upon the Office of the State Treasurer by law, to the Special Cash Fund of the State Treasury.

SECTION 3. TRANSFER The Director of State Finance, on July 1, 1998, shall transfer the sum of Thirteen Thousand Two Dollars (\$13,002.00) of the amount of One Hundred Seventy-one Thousand Two Hundred Eighty-one Dollars (\$171,281.00) originally appropriated to the Office of the State Treasurer by Section 11, Chapter 236, O.S.L. 1996, from any monies in the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1997, not otherwise appropriated, for duties imposed upon the Office of

the State Treasurer by law, to the Special Cash Fund of the State Treasury.

SECTION 4. TRANSFER The Director of State Finance, on July 1, 1998, shall transfer the sum of Two Hundred Seventeen Thousand Five Hundred Dollars (\$217,500.00) of the amount of One Million Eight Hundred Six Thousand Three Hundred Ninety-five Dollars (\$1,806,395.00) originally appropriated to the Department of Commerce by Section 1, Chapter 308, O.S.L. 1997, from any monies in the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 1998, not otherwise appropriated, for duties imposed upon the Department of Commerce by law, to the Special Cash Fund of the State Treasury.

SECTION 5. REPEALER Section 7 of Enrolled House Bill No. 3010 of the 2nd Session of the 46th Oklahoma Legislature, is hereby repealed.

SECTION 6. This act shall become effective June 30, 1998.

SECTION 7. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
